Iowa Code § 96.4(3) – Able to and Available for Work

**STATEMENT OF THE CASE:**

Ryder Integrated Logistics Inc, the employer/appellant,<sup>1</sup> appealed the Iowa Workforce Development (IWD) January 25, 2024, (reference 01) unemployment insurance (UI) decision. IWD found Mr. Rasmussen eligible for REGULAR (state) UI benefits as of December 24, 2023 because IWD concluded he was on a short-term layoff, and he was able to and available for work. On February 9, 2024, the Iowa Department of Inspections, Appeals, and Licensing (DIAL), UI Appeals Bureau mailed a notice of hearing to the employer and Mr. Rasmussen for a telephone hearing scheduled for February 26, 2024.

The administrative law judge held a telephone hearing on February 26, 2024. The employer participated in the hearing through Curtis Mauer, customer logistics manager. Mr. Rasmussen participated in the hearing personally. The administrative law judge took official notice of the administrative record.

**ISSUE:**

Is Mr. Rasmussen able to and available for work as of December 24, 2023?  
Is Mr. Rasmussen partially or temporarily unemployed as of December 24, 2023?

**FINDINGS OF FACT:**

Having reviewed the evidence in the record, the administrative law judge finds: Mr. Rasmussen began working for the employer, a base period employer, on March 6, 2023. He works as a full-time semi truck driver. His schedule is set, and the employer pays him \$26.00 per hour.

Before the week of December 24-30, the employer told Mr. Rasmussen and other drivers that the employer would have work available for them during this week, even if the work was not driving. Mr. Rasmussen applied for UI benefits effective December 24 because he believed that the employer would not offer him full-time work for the week of December 24-30. IWD set his weekly UI benefit amount at \$582.00.

The employer paid Mr. Rasmussen 8 hours of holiday pay for Monday, December 25, and 4 hours of holiday pay for Friday, December 29. Mr. Rasmussen showed up to work and worked for about 6.5 hours. Mr. Rasmussen left work when there was no more work available.

### **REASONING AND CONCLUSIONS OF LAW:**

For the reasons that follow, the administrative law judge concludes Mr. Rasmussen was partially unemployed the week of December 24-30, 2023 and IWD should charge this employer's account.

Iowa Code § 96.4(3) provides:

An unemployed individual shall be eligible to receive benefits with respect to any week only if the department finds that:

3. The individual is able to work, is available for work, and is earnestly and actively seeking work. This subsection is waived if the individual is deemed partially unemployed, while employed at the individual's regular job, as defined in section 96.1A, subsection 37, paragraph "b", unnumbered paragraph (1), or temporarily unemployed as defined in section 96.1A, subsection 37, paragraph "c". The work search requirements of this subsection and the disqualification requirement for failure to apply for, or to accept suitable work of section 96.5, subsection 3 are waived if the individual is not disqualified for benefits under section 96.5, subsection 1, paragraph "h".

Iowa Code § 96.1A(37) provides:

"Total and partial unemployment".

a. An individual shall be deemed "totally unemployed" in any week with respect to which no wages are payable to the individual and during which the individual performs no services.

b. An individual shall be deemed partially unemployed in any week in which either of the following apply:

(1) While employed at the individual's then regular job, the individual works less than the regular full-time week and in which the individual earns less than the individual's weekly benefit amount plus fifteen dollars.

(2) The individual, having been separated from the individual's regular job, earns at odd jobs less than the individual's weekly benefit amount plus fifteen dollars.

c. An individual shall be deemed temporarily unemployed if for a period, verified by the department, not to exceed four consecutive weeks, the individual is unemployed due to a plant shutdown, vacation, inventory, lack of work or emergency from the individual's regular job or trade in which the individual worked full-time and will again work full-time, if the individual's employment, although temporarily suspended, has not been terminated.

Iowa Code section 96.7(2)a(2)(a) provides:

2. Contribution rates based on benefit experience.

a. (2) The amount of regular benefits plus fifty percent of the amount of extended benefits paid to an eligible individual shall be charged against the account of the employers in the base period in the inverse chronological order in which the employment of the individual occurred.

(a) However, if the individual to whom the benefits are paid is in the employ of a base period employer at the time the individual is receiving the benefits, and the individual is receiving the same employment from the employer that the individual received during the individual's base period, benefits paid to the individual shall not be charged against the account of the employer. This provision applies to both contributory and reimbursable employers, notwithstanding subparagraph (3) and section 96.8, subsection 5.

Iowa Admin. Code r. 871-24.23(26) provide:

Availability disqualifications. The following are reasons for a claimant being disqualified for being unavailable for work.

(26) Where a claimant is still employed in a part-time job at the same hours and wages as contemplated in the original contract for hire and is not working on a reduced workweek basis different from the contract for hire, such claimant cannot be considered partially unemployed.

A person claiming benefits has the burden of proof that she is be able to work, available for work, and earnestly and actively seeking work.<sup>2</sup> To be able to work, "[a]n individual must be physically and mentally able to work in some gainful employment, not necessarily in the individual's customary occupation, but which is engaged in by others as a means of livelihood."<sup>3</sup> "An evaluation of an individual's ability to work for the purposes of determining that individual's eligibility for unemployment benefits must necessarily take into consideration the economic and legal forces at work in the general labor market in which the individual resides."<sup>4</sup>

In this case, the employer did not offer Mr. Rasmussen full-time work the week of December 24-30. Mr. Rasmussen worked less than his regular, full-time schedule and he earned less than his weekly UI benefit amount plus \$15.00. Mr. Rasmussen was partially unemployed the week of December 24-30, 2023, and he is eligible for UI benefits for this week. This employer's account is subject to charge because it did not offer Mr. Rasmussen full-time work this week.

**DECISION:**

The January 25, 2024 (reference 04) UI decision is MODIFIED IN FAVOR OF THE RESPONDENT, MR. RASMUSSEN. Mr. Rasmussen is partially unemployed the week of December 24-30, 2023, and he is eligible for UI benefits this week, as long as no other decision denies her UI benefits.

This employer's account is subject to charge.

AN APPEAL TO THE BOARD SHALL STATE CLEARLY:

- 1) The name, address, and social security number of the claimant.
- 2) A reference to the decision from which the appeal is taken.
- 3) That an appeal from such decision is being made and such appeal is signed.
- 4) The grounds upon which such appeal is based.

An Employment Appeal Board decision is final agency action. If a party disagrees with the Employment Appeal Board decision, they may then file a petition for judicial review in district court.

2. If no one files an appeal of the judge's decision with the Employment Appeal Board within fifteen (15) days, the decision becomes final agency action, and you have the option to file a petition for judicial review in District Court within thirty (30) days after the decision becomes final. **Note to Claimant:** It is important that you file your weekly claim as directed, while this appeal is pending, to protect your continuing right to benefits.
