STATEMENT OF THE CASE:

Claimant Jeffrey Thompson filed an appeal from the June 23, 2014, reference 04, unemployment insurance decision that denied benefits effective May 4, 2014 based on an agency conclusion that he was working enough hours to be considered employed and, therefore did not meet the “availability requirement” to be eligible for unemployment insurance benefits. Notices of hearing were mailed to the parties’ last-known addresses of record for a telephone hearing to be held at 3:00 p.m. on July 16, 2014. A review of the Appeals Bureau’s conference call system indicates that the claimant/appellant did not respond to the hearing notice instructions to provide a telephone number at which he could be reached for the hearing. The employer also did not provide a telephone number for the hearing. Based upon the claimant/appellant’s failure to participate in the hearing and the law, the administrative law judge enters the following findings of fact, reasoning and conclusions of law and decision.

ISSUE:

Should the appeal be dismissed based upon the claimant/appellant not participating in the hearing?

FINDINGS OF FACT:

The parties were properly notified of the scheduled hearing on this appeal. The claimant/appellant, Jeffrey Thompson, did not respond to the hearing notice instructions to provide a telephone number at which the appellant could be reached for the hearing. Mr. Thompson did not participate in the hearing or request a postponement of the hearing as required by the hearing notice.

The June 23, 2014, reference 04, unemployment insurance decision denied benefits effective May 4, 2014 based on an agency conclusion that the Mr. Thompson was working enough hours to be considered employed and, therefore, did not meet the “availability requirement” to be eligible for unemployment insurance benefits.

The administrative law judge notes from the claimant's appeal letter that he was not concerned about the period addressed in the June 23, 2014, reference 04, decision, but was instead interested in receiving benefits for the two weeks prior to the period in question. Workforce Development records indicate that benefits have been disbursed to the claimant for the period of April 20, 2014 through May 3, 2014.

REASONING AND CONCLUSIONS OF LAW:

The Iowa Administrative Procedures Act at Iowa Code section 17A.12(3) provides in pertinent part:

If a party fails to appear or participate in a contested case proceeding after proper service of notice, the presiding officer may, if no adjournment is granted, enter a default decision or proceed with the hearing and make a decision in the absence of the party. ... If a decision is rendered against a party who failed to appear for the hearing and the presiding officer is timely requested by that party to vacate the decision for good cause, the time for initiating a further appeal is stayed pending a determination by the presiding officer to grant or deny the request. If adequate reasons are provided showing good cause for the party's failure to appear, the presiding officer shall vacate the decision and, after proper service of notice, conduct another evidentiary hearing. If adequate reasons are not provided showing good cause for the party's failure to appear, the presiding officer shall deny the motion to vacate.

The Agency rules at Iowa Admin. Code r. 871-26.14(7) provide:

If a party has not responded to a notice of telephone hearing by providing the appeals bureau with the names and telephone numbers of the persons who are participating in the hearing by the scheduled starting time of the hearing or is not available at the telephone number provided, the presiding officer may proceed with the hearing. If the appealing party fails to provide a telephone number or is unavailable for the hearing, the presiding officer may decide the appealing party is in default and dismiss the appeal as provided in Iowa Code section 17A.12(3). The record may be reopened if the absent party makes a request to reopen the hearing under subrule 26.8(3) and shows good cause for reopening the hearing.

- a. If an absent party responds to the hearing notice while the hearing is in progress, the presiding officer shall pause to admit the party, summarize the hearing to that point, administer the oath, and resume the hearing.
- b. If a party responds to the notice of hearing after the record has been closed and any party which has participated is no longer on the telephone line, the presiding officer shall not take the evidence of the late party. Instead, the presiding officer shall inquire ex parte as to why the party was late in responding to the notice of hearing. For good cause shown, the presiding officer shall reopen the record and cause further notice of hearing to be issued to all parties of record. The record shall not be reopened if the presiding officer does not find good cause for the party's late response to the notice of hearing.
- c. Failure to read or follow the instructions on the notice of hearing shall not constitute good cause for reopening the record.

The claimant/appellant appealed the representative's decision but failed to participate in the hearing. The claimant/appellant has therefore defaulted on his appeal pursuant to Iowa Code section 17A.12(3) and Iowa Admin. Code r. 871-24.14(7), and the representative's decision remains in force and effect.

If the appellant disagrees with this decision, pursuant to the rule, the appellant must make a written request to the administrative law judge that the hearing be reopened within 15 days after the mailing date of this decision. The written request should be mailed to the administrative law judge at the address listed at the end of this decision and must explain the emergency or other good cause that prevented the appellant from participating in the hearing at its scheduled time.

DECISION:

The Claims Deputy's June 23, 2014, reference 04, unemployment insurance decision is affirmed. The decision that denied benefits effective May 4, 2014 based on an agency conclusion that the claimant did not meet the work availability requirement remains in effect.
