## STATEMENT OF THE CASE:

The employer filed an appeal from a fact-finding decision dated November 16, 2004, reference 01. The decision had been in the employer's favor. After realizing that the appeal was inadvertent, the employer requested that the appeal be withdrawn.

# REASONING AND CONCLUSIONS OF LAW:

A rule found 871 IAC 26.8(1) allows the administrative law judge to grant an appellant's request for the withdrawal of its appeal. A review of all matters of record persuades the administrative law judge that it is appropriate to allow the withdrawal of this appeal.

### **DECISION:**

The unemployment insurance decision dated November 16, 2004, reference 01, remains in effect. Benefits are withheld until the claimant has worked in and has been paid wages for insured work equal to ten times his weekly benefit amount, provided he is otherwise eligible.
