Section 96.3-7 – Recovery of Overpayment of Benefits

STATEMENT OF THE CASE:

Trina M. Levy (claimant) appealed a representative's May 17, 2005 decision (reference 02) that concluded she had been overpaid \$174.00 in benefits she received for the weeks ending April 23 and 30, 2005. The overpayment occurred as the result of a representative's May 16, 2005 decision that disqualified the claimant from receiving benefits as of April 17, 2005. After a hearing notice was mailed to the claimant's last-known address of record, a telephone hearing was held on June 20, 2005. The claimant participated in the hearing. Based on the evidence, the arguments of the claimant, and the law, the administrative law judge enters the following findings of fact, reasoning and conclusions of law, and decision.

ISSUE:

Has the claimant been overpaid benefits for the weeks ending April 23 and 30, 2005?

FINDINGS OF FACT:

The claimant established a claim for benefits during the week of April 17, 2005. She filed claims for the weeks ending April 23 and 30, 2005. She received a total of \$174.00 in benefits for these weeks.

The claimant appealed a representative's May 16, 2005 decision that disqualified her from receiving benefits as of April 17, 2005. This decision has been reversed. See decision for appeal 05A-UI-05818-DWT.

During the week of April 20, the employer offered the claimant another job assignment. The claimant declined this assignment because she had just accepted a permanent full-time job with another employer. The claimant started her full-time job the week of May 1, 2005.

REASONING AND CONCLUSIONS OF LAW:

If an individual receives benefits she is not legally entitled to receive, the Department shall recover the benefits even if the individual acted in good faith and is not at fault in receiving the overpayment. Iowa Code §96.3-7. Based on the decision for appeal 05A-UI-05818-DWT, the claimant is legally entitled to receive benefits for the weeks ending April 23 and 30, 2005. The claimant has not been overpaid \$174.00 in benefits she received for these weeks.

DECISION:

The representative's May 17, 2005 decision (reference 2) is reversed. The claimant is legally entitled to receive benefits for the weeks ending April 23 and 30, 2005. She has not been overpaid \$174.00 in benefits she received for these weeks.
