Section 96.6-2 - Timeliness of Protest Iowa Code Chapter 95 - Requalification

STATEMENT OF THE CASE:

The employer filed a timely appeal from the August 26, 2004, reference 01, decision that allowed benefits and found the protest untimely. After due notice was issued, a hearing was scheduled to be held by telephone conference call on September 27, 2004. The claimant did respond as did the employer. No hearing was held as claimant requalified for benefits and the envelope in which employer mailed its protest was not contained in the administrative file.

FINDINGS OF FACT:

Having reviewed the evidence in the record, the administrative law judge finds: The claimant's notice of claim was mailed to the employer's address of record on August 23, 2004. The

employer did protest by mail on August 23, 2004 and it was received at IWD on August 25, 2004 in the morning mail. The claimant has requalified for benefits since the separation from the employer.

## REASONING AND CONCLUSIONS OF LAW:

Iowa Code section 96.6-2 provides in pertinent part:

2. Initial determination. A representative designated by the director shall promptly notify all interested parties to the claim of its filing, and the parties have ten days from the date of mailing the notice of the filing of the claim by ordinary mail to the last known address to protest payment of benefits to the claimant.

The administrative law judge concludes that the employer filed its protest within the time period prescribed by the Iowa Employment Security Law because for the protest to have been received by August 25 from St. Louis, Missouri, employer's representative obviously mailed the protest by the due date on August 23, 2004. IWD has failed to maintain the envelope in which the protest was mailed and, without it, employer's representative's statement in the appeal letter is considered credible. The administrative law judge further concludes that the claimant has requalified for benefits since the separation from this employer. Accordingly, benefits are allowed and the account of the employer shall not be charged.

## DECISION:

The August 26, 2004, reference 01, decision is modified in favor of the appellant. The employer has filed a timely protest, and the claimant has requalified for benefits since the separation. Benefits are allowed, provided the claimant is otherwise eligible. The account of the employer shall not be charged.
