STATEMENT OF THE CASE

The claimant appealed two representative's decisions dated October 26, 2009, reference 02, and October 30, 2009, reference 03. A telephone hearing was scheduled for December 1, 2009. Prior to that date, the claimant's representative – her father, Brian McFadden – requested that the appeals be withdrawn. Mr. McFadden and investigator Karen Von Behren of Iowa Workforce Development (the Department) convened on December 1, 2009 and made a record regarding the withdrawal.

Ms. Von Behren stated on the record that there had been an error made in the Department's October 30, 2009 overpayment decision. The decision was inadvertently issued with a finding that the overpayment was a result of misrepresentation by the

claimant. Ms. Von Behren indicated this was an error and stated that she intends to amend the decision to state that the overpayment was not a result of misrepresentation.

Mr. McFadden stated on the record that he has power of attorney for the appellant and that it is her wish that the appeals be withdrawn.

The Department's regulations permit an appeal to be withdrawn at any time prior to the issuance of a decision upon the request of the appellant and with the approval of the presiding officer.1

DECISION

The appellant's request to withdraw her appeals is approved and the appeals are deemed withdrawn.
