Section 96.4-3 – Active Search for Work

STATEMENT OF THE CASE:

John Smith (claimant) an unemployment insurance decision dated February 1, 2005, reference 03, which issued him a warning for not making a minimum of two in-person job contacts during the week ending January 29, 2005. After a hearing notice was mailed to the claimant's last-known address of record, a telephone hearing was scheduled to be held on February 23, 2005. The claimant was not available when called for the hearing, and therefore, did not participate.

FINDINGS OF FACT:

The administrative law judge, having reviewed and considered the evidence in the record, finds that: The claimant established a claim for unemployment insurance benefits during the week of January 2, 2005. He was advised that each week he filed a claim for unemployment insurance

benefits, he was required to make a minimum of two in-person job contacts. During the week ending January 29, 2005, the claimant failed to make a minimum of two in-person job contacts.

REASONING AND CONCLUSIONS OF LAW:

The issue is whether the claimant is actively and earnestly seeking work. Before a claimant is considered eligible to receive weekly unemployment insurance benefits, he must make an active search for work. Iowa Code section 96.4-3. The administrative rule states an individual shall be ineligible for benefits for any period for which the department finds the individual failed to make an earnest and active search for work. An individual must make a sincere effort to find a job. 871 IAC 24.22(3).

The claimant has not established that he made two in-person job contacts for the week ending January 29, 2005. Making two in-person job contacts is evidence of earnestly and actively seeking work. The evidence does not support a finding that the claimant was earnestly and actively seeking work and, therefore, the warning shall remain in full force and effect.

DECISION:

The unemployment insurance decision dated February 1, 2005, reference 03, is affirmed. The warning shall remain in full force and effect.
