### STATEMENT OF THE CASE:

On February 10, 2023, claimant LK Nzinga Nlandu filed an appeal from the December 29, 2022 (reference 07) unemployment insurance decision that denied benefits effective December 4, 2022 based on a determination that claimant was unable to work. The parties were properly notified of the hearing. An in-person hearing was held in Cedar Rapids, Iowa at 2:45 p.m. on Tuesday, March 21, 2023. Appeal numbers 23A-UI-01373-LJ, 23A-UI-01374-LJ, 23A-UI-01375-LJ, 23A-UI-01376-LJ, 23A-UI-01377-LJ, and 23A-UI-01378-LJ were heard together and created one record. Claimant LK Nzinga Nlandu participated. A French interpreter from CTS Language Link (ID number 11925) provided interpretation assistance for the hearing. Iowa Workforce Development did not participate in the hearing. Claimant's Exhibit A was received and admitted into the record. The administrative law judge mailed claimant's letter from her healthcare provider back to her after the hearing. The administrative law judge took official notice of the administrative record.

## ISSUE:

Did the claimant file a timely appeal?

# FINDINGS OF FACT:

Having reviewed all of the evidence in the record, the administrative law judge finds: The decision denying benefits effective December 4, 2022 was mailed to claimant's last known address of record on December 29, 2022. She admits to receiving the decision, along with multiple other decisions, all around the same time. The first sentence of the decision states, "If this decision denies benefits and is not reversed on appeal, it may result in an overpayment which you will be required to repay." The decision contained a warning that an appeal must be postmarked or received by the Appeals Bureau by January 8, 2023.

Claimant was not able to read the decisions in full when she received them, so she had her daughter assist her. Her daughter explained that if she did not respond by "the second or third," she would have to repay the money she had received. Claimant did not have time to file an

appeal, as she had just given birth. Claimant filed her appeal on February 10, 2023, after receiving the overpayment decisions in the mail.

## **REASONING AND CONCLUSIONS OF LAW:**

For the reasons that follow, the administrative law judge concludes the claimant's appeal is untimely.

lowa Code § 96.6(2) provides, in pertinent part: "[u]nless the claimant or other interested party, after notification or within ten calendar days after notification was mailed to the claimant's last known address, files an appeal from the decision, the decision is final and benefits shall be paid or denied in accordance with the decision."

Iowa Admin. Code r. 871-24.35(1) provides:

1. Except as otherwise provided by statute or by division rule, any payment, appeal, application, request, notice, objection, petition, report or other information or document submitted to the division shall be considered received by and filed with the division..

Iowa Admin. Code r. 871-24.35(2) provides:

2. The submission of any payment, appeal, application, request, notice, objection, petition, report or other information or document not within the specified statutory or regulatory period shall be considered timely if it is established to the satisfaction of the division that the delay in submission was due to division error or misinformation or to delay or other action of the United States postal service.

The Iowa Supreme Court has declared that there is a mandatory duty to file appeals from representatives' decisions within the time allotted by statute, and that the administrative law judge has no authority to change the decision of a representative if a timely appeal is not filed. *Franklin v. IDJS*, 277 N.W.2d 877, 881 (Iowa 1979). Compliance with appeal notice provisions is jurisdictional unless the facts of a case show that the notice was invalid. *Beardslee v. IDJS*, 276 N.W.2d 373, 377 (Iowa 1979); see also *In re Appeal of Elliott* 319 N.W.2d 244, 247 (Iowa 1982).

Here, the claimant received the decision in the mail and, therefore, had an opportunity to file an appeal prior to the appeal deadline. Her daughter had helped her comprehend the contents of the decision; claimant understood that she may ultimately be overpaid benefits and have to repay benefits if she did not appeal the decision. While the administrative law judge understands that claimant had just given birth and was busy caring for herself and a newborn, this is not a good-cause circumstance under the law that can be used to extend the deadline for appealing. Claimant's delay was not due to an error or misinformation from the Department or due to delay or other action of the United States Postal Service. No other good cause reason has been established for the delay. Claimant's appeal was not filed on time and the administrative law judge lacks jurisdiction (authority) to decide the other issue in this matter.

# **DECISION:**

The December 29, 2022 (reference 07) unemployment insurance decision is affirmed. Claimant failed to file a timely appeal. The decision of the representative remains in effect.

APPEAL RIGHTS. If you disagree with the decision, you or any interested party may:

1. Appeal to the Employment Appeal Board within fifteen (15) days of the date under the judge's signature by submitting a written appeal via mail, fax, or online to:

The appeal period will be extended to the next business day if the last day to appeal falls on a weekend or a legal holiday.

### AN APPEAL TO THE BOARD SHALL STATE CLEARLY:

- 1) The name, address, and social security number of the claimant.
- 2) A reference to the decision from which the appeal is taken.
- 3) That an appeal from such decision is being made and such appeal is signed.
- 4) The grounds upon which such appeal is based.

An Employment Appeal Board decision is final agency action. If a party disagrees with the Employment Appeal Board decision, they may then file a petition for judicial review in district court.

2. If no one files an appeal of the judge's decision with the Employment Appeal Board within fifteen (15) days, the decision becomes final agency action, and you have the option to file a petition for judicial review in District Court within thirty (30) days after the decision becomes final. **Note to Parties:** YOU MAY REPRESENT yourself in the appeal or obtain a lawyer or other interested party to do so provided there is no expense to Workforce Development. If you wish to be represented by a lawyer, you may obtain the services of either a private attorney or one whose services are paid for with public funds.

**Note to Claimant:** It is important that you file your weekly claim as directed, while this appeal is pending, to protect your continuing right to benefits.
