STATEMENT OF THE CASE

Claimant Martin O'Keefe filed an appeal from a decision issued by Iowa Workforce Development ("IWD") dated August 16, 2010, reference 01. In the decision IWD found O'Keefe was ineligible to receive unemployment insurance benefits from August 8, 2010 through August 14, 2010 because he did not establish justifiable cause for failing to participate in reemployment services during that period. O'Keefe appealed. An administrative contested case hearing was scheduled for November 10, 2010. Jan

Holbrook appeared on behalf of IWD. O'Keefe also appeared. Documents 1 through 4 were admitted into the record.

Holbrook testified she reexamined IWD's decision in this case and believed O'Keefe should receive unemployment insurance benefits for August 8, 2010 through August 14, 2010. Holbrook stated IWD's decision should be reversed.

DECISION

IWD incorrectly determined claimant failed to establish justifiable cause for failing to participate in reemployment services, and its decision, reference 01, is reversed.
