STATEMENT OF THE CASE:

On May 23, 2024, Walner Joseph (claimant) filed an appeal that the Appeals Bureau treated as a timely appeal from the May 15, 2024 (reference 09) decision that held Mr. Joseph was overpaid \$5,820.00 in unemployment insurance benefits for 10 weeks between March 3, 2024 and May 11, 2024, due to a decision that disqualified him for benefits in connection with a discharge from Transport Corporation of America.

On May 28, 2024, Iowa Department of Inspections, Appeals, and Licensing (DIAL) UI Appeals Bureau mailed a notice of hearing to the parties at their last-known address of record for a telephone hearing set for 10:00 a.m. Iowa time (Central Daylight Time (CDT)). Neither party appeared for the hearing. Neither party complied with the hearing notice instructions to call the toll-free number at the time of the hearing. Based on the claimant/appellant's failure to participate in the hearing, the administrative law judge did not hold a hearing.

ISSUE:

Whether the appeal should be dismissed based on the claimant/appellant's failure to appear for and participate in the appeal hearing.

FINDINGS OF FACT:

Walner Joseph (claimant) is the appellant in this matter. DIAL UI Appeals Bureau properly notified the claimant/appellant of the scheduled appeal hearing. The administrative law judge was available for the hearing as scheduled. The claimant/appellant did not appear for or participate in the appeal hearing. The claimant/appellant did not request a postponement of the hearing. The claimant/appellant did not appear before the record closed 15 minutes after the scheduled start of the hearing. The administrative law judge did not hold a hearing because the claimant/appellant did not appear.

The May 15, 2024 (reference 09) decision held that Mr. Joseph was overpaid \$5,820.00 in unemployment insurance benefits for 10 weeks between March 3, 2024 and May 11, 2024, due

to a decision that disqualified him for benefits in connection with a discharge from Transport Corporation of America.

REASONING AND CONCLUSIONS OF LAW:

The Iowa Administrative Procedures Act at Iowa Code § 17A.12(3) provides, in relevant part:

If a party fails to appear or participate in a contested case proceeding after proper service of notice, the presiding officer may, if no adjournment is granted, enter a default decision or proceed with the hearing and make a decision in the absence of the party. ... If a decision is rendered against a party who failed to appear for the hearing and the presiding officer is timely requested by that party to vacate the decision for good cause, the time for initiating a further appeal is stayed pending a determination by the presiding officer to grant or deny the request. If adequate reasons are provided showing good cause for the party's failure to appear, the presiding officer shall vacate the decision and, after proper service of notice, conduct another evidentiary hearing. If adequate reasons are not provided showing good cause for the party's failure to appear, the presiding officer shall deny the motion to vacate.

Iowa Admin. Code r. 26.14(7) provides:

If a party has not responded to a notice of telephone hearing by providing the appeals bureau with the names and telephone numbers of the persons who are participating in the hearing by the scheduled starting time of the hearing or is not available at the telephone number provided, the presiding officer may proceed with the hearing. If the appealing party fails to provide a telephone number or is unavailable for the hearing, the presiding officer may decide the appealing party is in default and dismiss the appeal as provided in Iowa Code section 17A.12(3). The record may be reopened if the absent party makes a request in writing to reopen the hearing under subrule 26.8(3) and shows good cause for reopening the hearing.

a. If an absent party responds to the hearing notice while the hearing is in progress, the presiding officer shall pause to admit the party, summarize the hearing to that point, administer the oath, and resume the hearing.

b. If a party responds to the notice of hearing after the record has been closed and any party which has participated is no longer on the telephone line, the presiding officer shall not take the evidence of the late party.

c. Failure to read or follow the instructions on the notice of hearing shall not constitute good cause for reopening the record.

Due process requires notice and an opportunity to be heard, both of which were provided to the party/parties. The appellant is responsible for going forward with the case in a prompt and thoughtful manner. The hearing notice instructs the party/parties to call the toll-free number listed on hearing notice at the time the hearing is scheduled to begin. The appellant must be present at the start of the hearing to avoid a default judgment.

The claimant/appellant did not call in for the hearing and is in default. The appeal is dismissed. The IWD unemployment insurance decision remains in effect.

DECISION:

The claimant defaulted on the appeal. The appeal is DISMISSED. The May 15, 2024 (reference 09) overpayment decision remains in effect. That decision held the claimant was overpaid \$5,820.00 in unemployment insurance benefits for 10 weeks between March 3, 2024 and May 11, 2024, due to a decision that disqualified him for benefits in connection with a discharge from Transport Corporation of America.

REMAND:

This matter is REMANDED to Iowa Workforce Development Benefits Bureau for review and comparison of the April 8, 2024 (reference 03) decision, the April 22, 2024 (reference 04) decision, and the April 23, 2024 (reference 05) decision, all of which pertain to the same November 10, 2023 discharge. The employer representative for Transport Corporation of America (employer account number 181069) advises that Transport Corporation of America, TForce Holdings USA, Inc. (employer account number 665491) and TA Dedicated (employer account number 181069) are all the same employer doing business under different business names. The Benefits Bureau should consider the inconsistency between the reference 05 decision and the reference 03 and 04 decisions. The Benefits Bureau should consider whether modification, reversal or deletion of one or more of the decisions is appropriate. The Benefits Bureau should also consider the impact, if any, on the reference 09 overpayment decision.

1. Appeal to the Employment Appeal Board within fifteen (15) days of the date under the judge's signature by submitting a written appeal via mail, fax, or online to:

AN APPEAL TO THE BOARD SHALL STATE CLEARLY:

- 1) The name, address, and social security number of the claimant.
- 2) A reference to the decision from which the appeal is taken.
- 3) That an appeal from such decision is being made and such appeal is signed.
- 4) The grounds upon which such appeal is based.

An Employment Appeal Board decision is final agency action. If a party disagrees with the Employment Appeal Board decision, they may then file a petition for judicial review in district court.

2. If no one files an appeal of the judge's decision with the Employment Appeal Board within fifteen (15) days, the decision becomes final agency action, and you have the option to file a petition for judicial review in District Court within thirty (30) days after the decision becomes final. Additional information on how to file a petition can be found at lowa Code §17A.19, which is online at https://www.legis.iowa.gov/docs/code/17A.19.pdf.

Note to Parties: YOU MAY REPRESENT yourself in the appeal or obtain a lawyer or other interested party to do so provided there is no expense to Workforce Development. If you wish to be represented by a lawyer, you may obtain the services of either a private attorney or one whose services are paid for with public funds.

Note to Claimant: It is important that you file your weekly claim as directed, while this appeal is pending, to protect your continuing right to benefits.
