Iowa Code § 96.3(7) - Recovery of Benefit Overpayment

STATEMENT OF THE CASE:

On October 21, 2021, Luke Wilson (claimant/appellant) appealed the decision dated October 11, 2021 (reference 03) that concluded the claimant was overpaid unemployment insurance benefits in the amount of \$7,356.17 for the 15-week period between March 27 and September 19, 2020 as a result of a disqualification decision.

A telephone hearing was held on December 13, 2021, pursuant to due notice. Claimant participated personally. Claimant's fiancée Stephanie Krasho observed the hearing. The administrative law judge took official notice of the administrative record. No exhibits were admitted.

ISSUE:

Was the claimant overpaid regular, state unemployment insurance benefits?

FINDINGS OF FACT:

Having reviewed all of the evidence in the record, the administrative law judge finds:

The administrative record shows claimant received regular, state unemployment insurance benefits in the amount of \$493.00 per week for a total of 14 weeks, from the benefit week ending April 4, 2020 through the benefit week ending May 9, 2020 and from the benefit week ending August 1, 2020 and through the benefit week ending September 19, 2020. He also received benefits in the amount of \$454.17 in the week ending May 16, 2020. The total amount of regular, state unemployment insurance benefits paid during these periods is \$7,356.17.

Claimant was subsequently determined to be disqualified from benefits in a decision dated December 22, 2020. That decision remains in force. See 21A-UI-01911-LJ-T; 21B-UI-01911.

REASONING AND CONCLUSIONS OF LAW:

For the reasons set forth below, the decision dated October 11, 2021 (reference 03) that concluded the claimant was overpaid unemployment insurance benefits in the amount of \$7,356.17 for the 15-week period between March 27 and September 19, 2020 as a result of a disqualification decision is AFFIRMED.

Iowa Code section 96.3(7) provides, in pertinent part:

- 7. Recovery of overpayment of benefits.
- a. If an individual receives benefits for which the individual is subsequently determined to be ineligible, even though the individual acts in good faith and is not otherwise at fault, the benefits shall be recovered. The department in its discretion may recover the overpayment of benefits either by having a sum equal to the overpayment deducted from any future benefits payable to the individual or by having the individual pay to the department a sum equal to the overpayment.
- b. (1) (a) If the department determines that an overpayment has been made, the charge for the overpayment against the employer's account shall be removed and the account shall be credited with an amount equal to the overpayment from the unemployment compensation trust fund and this credit shall include both contributory and reimbursable employers, notwithstanding section 96.8, subsection 5.

The administrative record shows claimant received regular, state unemployment insurance benefits in the amount of \$493.00 per week for a total of 14 weeks, from the benefit week ending April 4, 2020 through the benefit week ending May 9, 2020 and from the benefit week ending August 1, 2020 and through the benefit week ending September 19, 2020. He also received benefits in the amount of \$454.17 in the week ending May 16, 2020. The total amount of regular, state unemployment insurance benefits paid during these periods is \$7,356.17.

Claimant was subsequently determined to be disqualified from benefits in a decision dated December 22, 2020. That decision remains in force. See 21A-UI-01911-LJ-T; 21B-UI-01911.

Because the claimant received benefits totaling \$7,356.17 for which he was later disqualified, he has been overpaid in that amount.

DECISION:

The decision dated October 11, 2021 (reference 03) that concluded the claimant was overpaid unemployment insurance benefits in the amount of \$7,356.17 for the 15-week period between March 27 and September 19, 2020 as a result of a disqualification decision is AFFIRMED.
