## STATEMENT OF THE CASE:

The claimant/appellant filed an appeal from the March 3, 2025 (reference 01) unemployment insurance decision that found claimant was ineligible for unemployment benefits as of February 2, 2025. The parties were properly notified of the hearing. A telephone hearing was held on April 1, 2025. The claimant, Amber Lewis, did participate personally. The employer, McGrew LLC, did not participate. No exhibits were offered or admitted into the record. The administrative law judge took official notice of the claimant's unemployment administrative record.

## **ISSUES:**

Is the claimant able to work and available for work?

Is the claimant employed for the same hours and wages?

Is the claimant totally, partially or temporarily unemployed? Is the employer's account subject to charge?

# FINDINGS OF FACT:

Having reviewed all of the evidence in the record, the administrative law judge finds:

Claimant began working for this employer in July of 2022 as a part-time bartender. At the time of hearing, the claimant was still employed in that position. She has had no reduction in hours or changes in the status of her employment with this employer.

Claimant's administrative records establish that claimant's base period included wages with this employer of \$1,239.00 during the first quarter of 2024; \$1,089.00 during the second quarter of 2024; \$1,172.00 during the third quarter of 2024 and \$811.00 during the fourth quarter of 2024.

The administrative record also establishes that the Claimant's base period included wages with the employer, 2nd Avenue Corner Pocket of \$1,924.00 in the first quarter of 2024, \$1,924.00 in

the second quarter of 2024, \$1,924.00 in the third quarter of 2024, \$1,924.00 in the fourth quarter of 2024, and \$740.00 in the first quarter of 2025.

The administrative record also establishes that the Claimant's base period included wages with the employer, Cedar River Landing Company of: \$4,538.00 in the first quarter of 2024, \$4,433.00 in the second quarter of 2024, \$3,883.00 in the third quarter of 2024 and \$4,659.00 in the fourth quarter of 2024.

At the end of the quarter 2024, the claimant separated from employment with her primary employer, Cedar River Landing. During the first quarter of 2025, the claimant separated from employment with her part-time employer, Second Avenue Corner Pocket.

# **REASONING AND CONCLUSIONS OF LAW:**

For the reasons that follow, the administrative law judge concludes as follows:

Iowa Code § 96.4(3) provides:

An unemployed individual shall be eligible to receive benefits with respect to any week only if the department finds that:

3. The individual is able to work, is available for work, and is earnestly and actively seeking work. This subsection is waived if the individual is deemed partially unemployed, while employed at the individual's regular job, as defined in section 96.1A, subsection 37, paragraph "b", subparagraph (1), or temporarily unemployed as defined in section 96.1A, subsection 37, paragraph "c". The work search requirements of this subsection and the disqualification requirement for failure to apply for, or to accept suitable work of section 96.5, subsection 3, are waived if the individual is not disqualified for benefits under section 96.5, subsection 1, paragraph "h".

Iowa Code section 96.1A(37) provides:

"Total and partial unemployment".

- a. An individual shall be deemed "totally unemployed" in any week with respect to which no wages are payable to the individual and during which the individual performs no services.
- b. An individual shall be deemed partially unemployed in any week in which either of the following apply:
- (1) While employed at the individual's then regular job, the individual works less than the regular full-time week and in which the individual earns less than the individual's weekly benefit amount plus fifteen dollars.
- (2) The individual, having been separated from the individual's regular job, earns at odd jobs less than the individual's weekly benefit amount plus fifteen dollars.
- c. An individual shall be deemed temporarily unemployed if for a period, verified by the department, not to exceed four consecutive weeks, the individual is unemployed due to a plant shutdown, vacation, inventory, lack of work, or emergency from the individual's regular job or trade in which the individual

worked full-time and will again work full-time, if the individual's employment, although temporarily suspended, has not been terminated.

Iowa Code section 96.7(2)a(2)(a), (b), and (c) provides

- 2. Contribution rates based on benefit experience.
- a. (2) The amount of regular benefits plus fifty percent of the amount of extended benefits paid to an eligible individual shall be charged against the account of the employers in the base period in the inverse chronological order in which the employment of the individual occurred.
- (a) However, if the individual to whom the benefits are paid is in the employ of a base period employer at the time the individual is receiving the benefits, and the individual is receiving the same employment from the employer that the individual received during the individual's base period, benefits paid to the individual shall not be charged against the account of the employer. This provision applies to both contributory and reimbursable employers, notwithstanding subparagraph (3) and section 96.8, subsection 5.
- (b) An employer's account shall not be charged with benefits paid to an individual who left the work of the employer voluntarily without good cause attributable to the employer or to an individual who was discharged for misconduct in connection with the individual's employment, or to an individual who failed without good cause, either to apply for available, suitable work or to accept suitable work with that employer, but shall be charged to the unemployment compensation fund. This paragraph applies to both contributory and reimbursable employers, notwithstanding section 96.8, subsection 5.
- (c) The amount of benefits paid to an individual, which is solely due to wage credits considered to be in an individual's base period due to the exclusion and substitution of calendar quarters from the individual's base period under section 96.23, shall be charged against the account of the employer responsible for paying the workers' compensation benefits for temporary total disability or during a healing period under section 85.33, section 85.34, subsection 1, or section 85A.17, or responsible for paying indemnity insurance benefits.

Iowa Admin. Code r. 871-23.43(4)a provides in part:

- (4) Supplemental employment.
- a. An individual, who has been separated with cause attributable to the regular employer and who remains in the employ of the individual's part-time, base period employer, continues to be eligible for benefits as long as the individual is receiving the same employment from the part-time employer that the individual received during the base period. The part-time employer's account, including the reimbursable employer's account, may be relieved of benefit charges.

McGrew LLC is the claimant's part-time employer. The claimant's primary employment was Cedar River Landing Company. That employment ended at the end of the fourth quarter 2024. Claimant has received the same employment with this employer, McGrew LLC, as during her base period. Claimant is not partially unemployed with regards to employer, McGrew LLC.


Benefits are denied. Inasmuch as the current part-time employer is offering the same wages and hours as in the base period.

## **DECISION:**

The March 3, 2025 (reference 01) unemployment insurance decision is affirmed pending the outcome of the remanded matter. The claimant is not partially unemployed with regards to her current employer.

# **REMAND:**

The issue of whether the claimant is eligible for benefits due to her separation from employment from her primary employer, Cedar River Landing Company is remanded for investigation and determination.

**APPEAL RIGHTS.** If you disagree with the decision, you or any interested party may:

1. Appeal to the Employment Appeal Board within fifteen (15) days of the date under the judge's signature by submitting a written appeal via mail, fax, or online to:

The appeal period will be extended to the next business day if the last day to appeal falls on a weekend or a legal holiday.

## AN APPEAL TO THE BOARD SHALL STATE CLEARLY:

- 1) The name, address, and social security number of the claimant.
- 2) A reference to the decision from which the appeal is taken.
- 3) That an appeal from such decision is being made and such appeal is signed.
- 4) The grounds upon which such appeal is based.

An Employment Appeal Board decision is final agency action. If a party disagrees with the Employment Appeal Board decision, they may then file a petition for judicial review in district court.

2. If no one files an appeal of the judge's decision with the Employment Appeal Board within fifteen (15) days, the decision becomes final agency action, and you have the option to file a petition for judicial review in District Court within thirty (30) days after the decision becomes final. **Note to Claimant:** It is important that you file your weekly claim as directed, while this appeal is pending, to protect your continuing right to benefits.
