STATEMENT OF THE CASE:

Renee A McArtor, the claimant/appellant, filed an appeal from the August 19, 2020 (reference 01) unemployment insurance decision that denied REGULAR unemployment insurance benefits. The parties were properly notified of the hearing. A telephone hearing is scheduled for October 11, 2021 at 10:00 a.m. Prior to the hearing date, Ms. McArtor submitted a written request to withdraw her appeal.

ISSUE:

Should Ms. McArtor's request to withdraw her appeal be granted?

FINDINGS OF FACT:

Having reviewed all of the evidence in the record, the administrative law judge finds: Ms. McArtor requested to withdraw her appeal. The request was submitted in writing and sent via email on October 7, 2021. The lowa Workforce Development Unemployment Insurance Appeals Bureau received the written withdrawal of appeal on October 7, 2021.

REASONING AND CONCLUSIONS OF LAW:

An appellant may submit a written request to withdraw an appeal at any time prior to the issuance of a decision. lowa Admin. Code r. 871-26.8(1). Based on the available record in the appeal file, and in accordance with the applicable statutes and rules, Ms. McArtor's request to withdraw her appeal should be approved.

DECISION:

Ms. McArtor's request to withdraw her appeal of the August 19, 2020 (reference 01) unemployment insurance decision is approved. That decision shall stand and remain in full force and effect.

The hearing scheduled for October 11, 2021 at 10:00 a.m. is cancelled.
