## STATEMENT OF THE CASE:

Donna Fischels, claimant/appellant, appealed from the April 6, 2022, (reference 02) unemployment insurance decision that found claimant was overpaid \$1,595.00 in regular unemployment benefits for 5 weeks between 04/26/20 and 05/30/20 due to the July 17, 2020, decision (reference 01) that disqualified her as not able and available for work. Notices of hearing were mailed to the parties' last known addresses of record for a telephone hearing scheduled for June 3, 2022, at 1:00PM. The department did not participate. Claimant personally participated. The following hearings were held together as part of a consolidated hearing: Appeals 22A-UI-09530-DH-T; and 22A-UI-09531-DH-T. Judicial notice was taken of the administrative record and DBIN.

#### **ISSUE:**

Was the claimant overpaid benefits?

#### FINDINGS OF FACT:

Having heard the testimony and reviewed the evidence in the record, the undersigned finds:

A July 17, 2020 (reference 01) decision was issued that denied benefits as of 04/26/20 as records show claimant was still employed in her job at the same hours and wages. Claimant appealed the decision. Appeal 20A-UI-09087-JC-T was heard on September 16, 2020, and affirmed the underlying decision, finding claimant would not otherwise be eligible for benefits until such time as she was able and available for work. The appeal decision was issued September 23, 2020. Claimant appealed that decision to the Employment Appeal Board (EAB). The EAB issued decision 22B-UI-09087 on April 14, 2022, dismissing claimant's appeal to the EAB as not timely filed, which deprived the EAB from having jurisdiction to review the merits of the appeal, which in effect kept the decision in 20A-UI-09087-JC-T, which denied benefits, as final. No further appeals were made.

Claimant filed a new claim for unemployment insurance benefits with an original claim date of 04/26/20. Claimant's weekly benefit amount (WBA) was \$319.00. Claimant was paid \$1,595.00 in regular unemployment benefits for 5 weeks between 04/26/20 and 05/30/20.

# REASONING AND CONCLUSIONS OF LAW:

The issue in this case is whether the claimant was overpaid regular unemployment insurance benefits. For the reasons set forth below, it is determined claimant was overpaid benefits.

lowa Code § 96.3(7) provides, in pertinent part:

7. Recovery of overpayment of benefits.

a. If an individual receives benefits for which the individual is subsequently determined to be ineligible, even though the individual acts in good faith and is not otherwise at fault, the benefits shall be recovered. The department in its discretion may recover the overpayment of benefits either by having a sum equal to the overpayment deducted from any future benefits payable to the individual or by having the individual pay to the department a sum equal to the overpayment.

The EAB issued decision 22B-UI-09087 dismissing claimant's appeal of 20A-UI-09087-JC-T as not timely and kept the decision in 20A-UI-09087-JC-T, affirmed the underlying decision (reference 01) that denied benefits as of 04/26/20 as claimant was still employed in her job at the same hours and wages, making her not able and available for work. There were no further appeals and the decision remains in effect. With claimant not entitled to benefits as of 04/26/20, claimant was overpaid \$1,595.00 in regular unemployment benefits for 5 weeks between 04/26/20 and 05/30/20. The benefits are to be repaid.

## **DECISION:**

The April 6, 2022, (reference 02) unemployment insurance decision finding claimant was overpaid \$1,595.00 in regular unemployment benefits is **AFFIRMED**.

1) The name, address, and social security number of the claimant.

- 2) A reference to the decision from which the appeal is taken.
- 3) That an appeal from such decision is being made and such appeal is signed.

4) The grounds upon which such appeal is based.

An Employment Appeal Board decision is final agency action. If a party disagrees with the Employment Appeal Board decision, they may then file a petition for judicial review in district court.

2. If no one files an appeal of the judge's decision with the Employment Appeal Board within fifteen (15) days, the decision becomes final agency action, and you have the option to file a petition for judicial review in District Court within thirty (30) days after the decision becomes final.
