Section 96.3-7 – Overpayment of Benefits

### STATEMENT OF THE CASE:

The claimant, Aimee J. Miller, filed a timely appeal from an unemployment insurance decision dated October 15, 2004, reference 04, determining that she is overpaid unemployment insurance benefits. After due notice was issued, a telephone hearing was held on November 12, 2004, with the claimant participating. This appeal was consolidated with appeal number 04A-UI-11308-RT for the purposes of the hearing with the consent of the parties. Although there was no employer or respondent noticed in this appeal, the employer in the appeal with which this appeal was consolidated, Electrolux Home Products, Inc., doing business as Frigidaire, participated in the hearing by LaVonne Russell, Benefits Administrator.

The administrative law judge takes official notice of Iowa Workforce Development Department unemployment insurance records for the claimant.

#### FINDINGS OF FACT:

Having heard the testimony of the witnesses and having examined all of the evidence in the record, the administrative law judge finds: The claimant filed for unemployment insurance benefits effective September 19, 2004 and received unemployment insurance benefits in the amount of \$702.00 as follows: \$351.00 per week for two weeks, benefit weeks ending October 2 and 9, 2004. For benefit week ending September 25, 2004, the claimant received no benefits having received wages and vacation pay in an amount sufficient to cancel benefits. Beginning with benefit week ending October 16, 2004 and continuing thereafter the claimant received no benefits being shown as disqualified as a result of a discharge. The claimant is now shown as overpaid the amount received, \$702.00, and that is the subject of this appeal. In a decision in appeal number 04A-UI-11308-RT, the administrative law judge concluded that the claimant was not entitled to receive such unemployment insurance benefits because her separation from the employer, Electrolux Home Products, Inc., doing business as Frigidaire, was disqualifying.

## REASONING AND CONCLUSIONS OF LAW:

The question presented by this appeal is whether the claimant is overpaid unemployment insurance benefits in the amount of \$702.00 for two weeks between September 26, 2004 and October 9, 2004. The administrative law judge concludes that the claimant is overpaid that amount for that period.

Iowa Code section 96.3-7 provides:

7. Recovery of overpayment of benefits. If an individual receives benefits for which the individual is subsequently determined to be ineligible, even though the individual acts in good faith and is not otherwise at fault, the benefits shall be recovered. The department in its discretion may recover the overpayment of benefits either by having a sum equal to the overpayment deducted from any future benefits payable to the individual or by having the individual pay to the department a sum equal to the overpayment.

If the department determines that an overpayment has been made, the charge for the overpayment against the employer's account shall be removed and the account shall be credited with an amount equal to the overpayment from the unemployment compensation trust fund and this credit shall include both contributory and reimbursable employers, notwithstanding section 96.8, subsection 5.

The administrative law judge concludes that the claimant has received unemployment insurance benefits in the amount of \$702.00 since separating from her employer on or about September 20, 2004 and filing for such benefits effective September 19, 2004. In appeal number 04A-UI-11308-RT, the administrative law judge concluded that the claimant was not entitled to receive such benefits because her separation from her employer, Electrolux Home Products, Inc., doing business as Frigidaire was disqualifying. Accordingly, the administrative law judge concludes that the claimant has received unemployment insurance benefits in the amount of \$702.00 to which she is not entitled and she is, therefore, overpaid such benefits. The administrative law judge further concludes that these benefits must be recovered in accordance with the provisions of lowa law.

# **DECISION:**

The representative's decision of October 15, 2004, reference 04, is affirmed. The claimant, Aimee J. Miller, is overpaid unemployment insurance benefits in the amount of \$702.00 for two weeks between September 26, 2004 and October 9, 2004.
