Section 96.4-3 – Eligibility for Benefits

STATEMENT OF THE CASE:

Ruth A. Folsom filed a timely appeal from an unemployment insurance decision dated March 29, 2004 reference 08 which held her ineligible for unemployment insurance benefits for the two weeks ending March 20, 2004. After due notice was issued, a telephone hearing was held April 19, 2004 with Ms. Folsom participating. This matter is considered on the consolidated record with 04A-UI-03523, 03524, 03525, 03527, 04036, and 04037-AT. The administrative law judge takes official notice of agency benefit payment records.

FINDINGS OF FACT:

Having heard the testimony of the witness and having examined all of the evidence in the record, the administrative law judge finds: During the two weeks ending March 20, 2002 Ms. Folsom was unable to work because of a flare-up of an old back injury.

REASONING AND CONCLUSIONS OF LAW:

The question is whether Ms. Folsom is entitled to receive unemployment insurance benefits for the two weeks ending March 20, 2004. She is not

Iowa Code Section 96.4-3 provides:

An unemployed individual shall be eligible to receive benefits with respect to any week only if the department finds that:

3. The individual is able to work, is available for work, and is earnestly and actively seeking work. This subsection is waived if the individual is deemed partially unemployed, while employed at the individual's regular job, as defined in section 96.19, subsection 38, paragraph "b", unnumbered paragraph 1, or temporarily unemployed as defined in section 96.19, subsection 38, paragraph "c". The work search requirements of this subsection and the disqualification requirement for failure to apply for, or to accept suitable work of section 96.5, subsection 3 are waived if the individual is not disqualified for benefits under section 96.5, subsection 1, paragraph "h".

An individual must be medically able to work in order to be eligible for unemployment insurance benefits. The evidence establishes that Ms. Folsom was not able to work during the two weeks in question. Benefits must be withheld.

DECISION:

The unemployment insurance decision dated March 29, 2004 reference 08 is affirmed. The claimant is ineligible for unemployment insurance benefits for the two weeks ending March 20, 2004.
