# STATEMENT OF THE CASE:

The claimant/appellant filed an appeal from the January 14, 2021 (reference 02) unemployment insurance decision that found claimant was not eligible for unemployment benefits effective January 10, 2021, because claimant failed to participate in a reemployment and eligibility appointment. A subsequent initial decision restored benefits to claimant effective January 17, 2021 after he completed his reemployment and eligibility appointment.

After proper notice, a telephone hearing was scheduled for 9:00 a.m. on March 22, 2021. At the time of the hearing, claimant stated his intent to cancel his appeal. The request was recorded using the Appeals Bureau conference call software, and no hearing was held.

### **ISSUE:**

Should the request to withdraw the appeal be granted?

#### FINDINGS OF FACT:

The administrative law judge, having considered the evidence in the record, finds that: A request has been made by the appealing party to withdraw the appeal. The request has been recorded, using the Appeals Bureau conference calling software.

# **REASONING AND CONCLUSIONS OF LAW:**

For the reasons that follow, the administrative law judge concludes the claimant's request to withdraw his appeal is granted.

Iowa Admin. Code r. 871-26.8(1) provides:

(1) An appeal may be withdrawn at any time prior to the issuance of a decision upon the request of the appellant and with the approval of an administrative law judge or the manager or chief administrative law judge of the appeals bureau. Requests for withdrawal may be made in writing or orally, provided the oral request is taperecorded by the presiding officer.

An appeal may be dismissed upon the request of a party or in the agency's discretion when the issue or issues on appeal have been resolved in the appellant's favor.

The administrative law judge has reviewed the records and files herein and concludes that the request of the appealing party to withdraw the appeal should be approved.

### The hearing scheduled for March 22, 2021 at 9:00 a.m. is cancelled.

#### **DECISION:**

The unemployment insurance decision dated January 14, 2021, (reference 02) is affirmed. The request of the appealing party to withdraw the appeal is approved, and the decision of the representative shall stand and remain in full force and effect. **The hearing scheduled for March 22, 2021 at 9:00 a.m. is cancelled.**
