**STATEMENT OF THE CASE:**

On August 15, 2022, Flynn Co. Inc. (employer) filed an appeal from the statement of charges dated August 9, 2022, reference 01, for the second quarter of 2022. A hearing was held on September 20, 2022, pursuant to due notice. Matthew T. Liberg (claimant) did not participate. The employer participated through President, Jeff Flynn. The department's Exhibits D1 through D5 were admitted into the record.

**ISSUES:**

- I. Was the employer's protest timely?
- II. Was the employer's appeal from the statement of charges timely?

**FINDINGS OF FACT:**

Having reviewed all of the evidence in the record, the administrative law judge finds: The claimant was on a temporary layoff from the employer and filed a claim for benefits effective December 5, 2021. (DBRO). The notice of claim was mailed to the employer's address of record on December 7, 2021. (Exhibit D-1). The employer received the notice of claim and did not protest the claim since claimant was on a temporarily lay off. The employer received the fourth quarter of 2021 statement of charges and the first quarter of 2022 statement of charges and does not dispute them since claimant was on a temporary layoff. (Exhibits D-2 & D-3).

On Monday, April 11, 2022, claimant returned to work for the employer. Claimant continued to file for benefits the week ending April 16, 2022, April 23, 2022, and April 30, 2022. (DBRO). The first notice the employer received that claimant was still filing for benefits was the second quarter statement of charges mailed August 9, 2022. (Exhibit D-4). The employer filed its appeal of that statement of charges on August 15, 2022. (Exhibit D-5). The employer disputes the amount the employer's been charged for benefits since claimant should have only received two weeks of unemployment benefits in the second quarter of 2022.

## REASONING AND CONCLUSIONS OF LAW:

For the reasons that follow, the administrative law judge concludes the employer did file a timely appeal to the statement of charges.

Iowa Code section 96.6(2) provides, in pertinent part:

Filing – determination – appeal.

2. Initial determination. A representative designated by the director shall promptly notify all interested parties to the claim of its filing, and the parties have ten days from the date of mailing the notice of the filing of the claim by ordinary mail to the last known address to protest payment of benefits to the claimant.

Iowa Code section 96.7(2)a(6) provides:

Employer contribution and reimbursements.

2. Contribution rates based on benefit experience.

a. (6) Within forty days after the close of each calendar quarter, the department shall notify each employer of the amount of benefits charged to the employer's account during that quarter. The notification shall show the name of each individual to whom benefits were paid, the individual's social security number, and the amount of benefits paid to the individual. An employer which has not been notified as provided in section 96.6, subsection 2, of the allowance of benefits to an individual, may within thirty days after the date of mailing of the notification appeal to the department for a hearing to determine the eligibility of the individual to receive benefits. The appeal shall be referred to an administrative law judge for hearing and the employer and the individual shall receive notice of the time and place of the hearing.

Iowa Admin. Code r. 871-26.4 provides, in relevant part:

2. An appeal from an initial decision concerning the allowance or denial of benefits shall be filed, by mail, facsimile, or e-mail, online, or in person, not later than ten calendar days, as determined by the postmark or the date stamp after the decision was mailed to the party at its last-known address and shall state the following:

- a. The name, address and social security number of the claimant;
- b. A reference to the decision from which appeal is taken; and,
- c. The grounds upon which the appeal is based.

3. Notwithstanding the provisions of subrule 26.4(2), a contributory employer, which has not previously received a notice of the filing of a valid claim for benefits, may appeal an individual's eligibility to receive benefits within 30 days from the mailing date of the quarterly statement of benefit charges.

4. Also notwithstanding the provisions of subrule 26.4(2), a reimbursable employer, which has not previously received a notice of the filing of a valid claim for benefits, may appeal an individual's eligibility to receive benefits within 15 days of the mailing date of the quarterly billing of benefit charges.

The employer filed its appeal of the statement of charges within the time period prescribed by the Iowa Employment Security Law because the statement of charges for the second quarter was the employer's first notice that claimant was continuing to file for benefits after he returned to work. The employer's appeal of that statement was within thirty days and is timely.

The issue of whether the claimant incorrectly reported his wages for the second quarter of 2022 is remanded to the Integrity Bureau for a wage investigation and determination.

**DECISION:**

The August 9, 2022, reference 00, statement of charges for the second quarter of 2022 is affirmed, pending the outcome of the remanded issue. The employer has filed a timely appeal from that statement of charges, as the second quarter statement of charges was the employer's first notice claimant continued to file for benefits in the second quarter after he returned to work.

**REMAND:**

The issue of whether the claimant correctly reported his wages in the second quarter of 2022 is remanded to the Integrity Bureau for a wage investigation and determination.

AN APPEAL TO THE BOARD SHALL STATE CLEARLY:

- 1) The name, address, and social security number of the claimant.
- 2) A reference to the decision from which the appeal is taken.
- 3) That an appeal from such decision is being made and such appeal is signed.
- 4) The grounds upon which such appeal is based.

An Employment Appeal Board decision is final agency action. If a party disagrees with the Employment Appeal Board decision, they may then file a petition for judicial review in district court.

2. If no one files an appeal of the judge's decision with the Employment Appeal Board within fifteen (15) days, the decision becomes final agency action, and you have the option to file a petition for judicial review in District Court within thirty (30) days after the decision becomes final. Additional information on how to file a petition can be found at Iowa Code §17A.19, which is online at <https://www.legis.iowa.gov/docs/code/17A.19.pdf> or by contacting the District Court Clerk of Court <https://www.iowacourts.gov/iowa-courts/court-directory/>.

**Note to Parties:** YOU MAY REPRESENT yourself in the appeal or obtain a lawyer or other interested party to do so provided there is no expense to Workforce Development. If you wish to be represented by a lawyer, you may obtain the services of either a private attorney or one whose services are paid for with public funds.

**Note to Claimant:** It is important that you file your weekly claim as directed, while this appeal is pending, to protect your continuing right to benefits.
