#### STATEMENT OF THE CASE:

Smithfield Fresh Meats Corp, the employer/appellant, appealed the Iowa Workforce Development (IWD) September 6, 2023 (reference 01) unemployment insurance (UI) decision. IWD found Mr. Akech eligible for REGULAR (state) UI benefits because IWD concluded the employer discharged him from work on August 15, 2023 for a reason that did not disqualify him from receiving UI benefits. On September 19, 2023, the Iowa Department of Inspections, Appeals, and Licensing (DIAL), UI Appeals Bureau mailed a notice of hearing to the employer and Mr. Akech for a telephone hearing scheduled for October 3, 2023.

The undersigned administrative law judge held a telephone hearing on October 3, 2023. The employer participated in the hearing through Abby Lansink, associate human resources manager. Mr. Akech did not participate in the hearing. The undersigned took official notice of the administrative record and admitted Employer's Exhibit 1 as evidence.

## **ISSUES:**

Did the employer discharge Mr. Akech from employment for disqualifying job-related misconduct?

Did IWD overpay Mr. Akech UI benefits?

If so, should he repay the benefits?

## **FINDINGS OF FACT:**

Having reviewed the evidence in the record, the administrative law judge finds: Mr. Akech began working for the employer on April 25, 2023. He worked as a full-time production worker. His employment ended on August 15, 2023.

The employer's policy provides that an employee who is absent or tardy is required to call the employer's attendance line before the employee's scheduled shift. The policy further provides that an employee accrues one point for absences due to medical reasons if the employee provides a doctor's note. The policy also provides that the employer will terminate the

employment of an employee who accrues 12 points. Mr. Akech received a copy of the policy on his hire date.

Mr. Akech called in on Tuesday, August 8, Wednesday, August 9 and Thursday, August 10, and he provided a doctor's note excusing him from work these three days. The employer gave Mr. Akech one point for these three absences, which put him at 13 total points. On Tuesday, August 15, the employer terminated Mr. Akech's employment for accruing 13 points.

## **REASONING AND CONCLUSIONS OF LAW:**

For the reasons that follow, the undersigned concludes the employer discharged Mr. Akech from employment for a reason that does not disqualify him from receiving UI benefits.

lowa Code section 96.5(2)(a) and (d) provide:

An individual shall be disqualified for benefits:

- 2. Discharge for misconduct. If the department finds that the individual has been discharged for misconduct in connection with the individual's employment:
- a. The individual shall be disqualified for benefits until the individual has worked in and has been paid wages for insured work equal to ten times the individual's weekly benefit amount, provided the individual is otherwise eligible.
- d. For the purposes of this subsection, "misconduct" means a deliberate act or omission by an employee that constitutes a material breach of the duties and obligations arising out of such the employee's contract of employment. Misconduct is limited to conduct evincing such willful or wanton disregard of an employer's interest as is found in deliberate violation or disregard of standards of behavior which the employer has the right to expect of employees, or in carelessness or negligence of such degree of recurrence as to manifest equal culpability, wrongful intent or evil design, or to show an intentional and substantial disregard of the employer's interests or of the employee's duties and obligations to the employer. Misconduct by an individual includes but is not limited to all of the following:

...

(9) Excessive unexcused tardiness or absenteeism.

Iowa Admin. Code r. 871-24.32(7) and (8) provide:

- (7) Excessive unexcused absenteeism. Excessive unexcused absenteeism is an intentional disregard of the duty owed by the claimant to the employer and shall be considered misconduct except for illness or other reasonable grounds for which the employee was absent and that were properly reported to the employer. [Emphasis added.]
- (8) Past acts of misconduct. While past acts and warnings can be used to determine the magnitude of a current act of misconduct, a discharge for misconduct cannot be based on such past act or acts. The termination of employment must be based on a current act.

The purpose of subrule eight is to assure that an employer does not save up acts of misconduct and spring them on an employee when an independent desire to terminate arises.

Excessive absenteeism is not considered misconduct unless the excessive absences are also unexcused. The requirements for a finding of misconduct based on absences are twofold. First, the absences must be excessive.<sup>2</sup> The determination of whether absenteeism is excessive necessarily requires consideration of past acts and warnings.<sup>3</sup> Second, the absences must be unexcused.<sup>4</sup> The requirement of "unexcused" can be satisfied in two ways. An absence can be unexcused either because it was not for "reasonable grounds," or because it was not "properly reported."<sup>5</sup>

An employer's no-fault absenteeism policy or point system does not, on its own, decide the issue of qualification for UI benefits. Absences due to properly reported illness cannot constitute work-connected misconduct since they are not voluntary. This is true even if the employer was fully within its rights to assess points or impose discipline up to or including discharge for the absence under its attendance policy. Medical documentation is not essential to a determination that an absence due to illness should be treated as excused. Absences related to other issues such as transportation, lack of childcare, and oversleeping are not considered excused. When a claimant does not provide an excuse for an absence the absences is deemed unexcused.

The employer has the burden of proof in establishing disqualifying job misconduct.<sup>10</sup> The issue is not whether the employer made a correct decision in separating the claimant from employment, but whether the claimant is entitled to unemployment insurance benefits.<sup>11</sup> Misconduct must be "substantial" to warrant a denial of job insurance benefits.<sup>12</sup>

In an at-will employment environment an employer may discharge an employee for any number of reasons or no reason at all if it is not contrary to public policy, but if it fails to meet its burden of proof to establish job related misconduct as the reason for the separation, it incurs potential liability for unemployment insurance benefits related to that separation. A determination as to whether an employee's act is misconduct does not rest solely on the interpretation or application of the employer's policy or rule. A violation of the employer's policy or rule is not necessarily disqualifying misconduct even if the employer was fully within its rights to impose discipline up to or including discharge for the incident under its policy.

The most recent incident leading to Mr. Akech's discharge must be a current act of misconduct to disqualify him from receiving UI benefits. The most recent act for which the employer terminated Mr. Akech's employment was because of his August 8, 9, and 10 absences. Mr. Akech properly reported these absences to the employer and the absences were for a good cause — illness. The August 8, 9, and 10 absences are excused under lowa law and not

misconduct. Since the employer has failed to establish a current act of misconduct on the part of Mr. Akech, he is eligible for UI benefits.

Since Mr. Akech is eligible for REGULAR (state) UI benefits per this decision, the issues of overpayment and repayment are moot. An issue being moot means there is nothing left to decide.<sup>13</sup>

#### **DECISION:**

The September 6, 2023 (reference 01) UI decision is AFFIRMED. The employer discharged Mr. Akech from employment for a reason that does not disqualify him from receiving UI benefits. Mr. Akech is eligible for UI benefits, as long as no other decision denies him UI benefits

1. Appeal to the Employment Appeal Board within fifteen (15) days of the date under the judge's signature by submitting a written appeal via mail, fax, or online to:

- 1) The name, address, and social security number of the claimant.
- 2) A reference to the decision from which the appeal is taken.
- 3) That an appeal from such decision is being made and such appeal is signed.
- 4) The grounds upon which such appeal is based.

An Employment Appeal Board decision is final agency action. If a party disagrees with the Employment Appeal Board decision, they may then file a petition for judicial review in district court.

2. If no one files an appeal of the judge's decision with the Employment Appeal Board within fifteen (15) days, the decision becomes final agency action, and you have the option to file a petition for judicial review in District Court within thirty (30) days after the decision becomes final.
