Section 96.3-7 - Recovery of Overpayment of Benefits

STATEMENT OF THE CASE:

Claimant appealed a representative's decision dated December 30, 2003, reference 03, that concluded claimant was overpaid unemployment insurance benefits in the amount of \$168.00 as a result of a disqualification decision. A telephone hearing was scheduled and held on January 28, 2004 pursuant to due notice. Claimant did participate.

FINDINGS OF FACT:

The administrative law judge, having considered all of the evidence in the record, finds that: The overpayment issue in this case was created by a disqualification decision that has now been affirmed. All of the pay should have been attributed to the first week of unemployment.

Claimant worked on an overtime-incentive plan, which gave extra vacation pay for overtime hours worked. Claimant had one week of vacation pay accrued on the incentive program. The vacation pay should not have been split into two weeks.

REASONING AND CONCLUSIONS OF LAW:

Iowa Code Section 96.3-7 provides:

7. Recovery of overpayment of benefits. If an individual receives benefits for which the individual is subsequently determined to be ineligible, even though the individual acts in good faith and is not otherwise at fault, the benefits shall be recovered. The department in its discretion may recover the overpayment of benefits either by having a sum equal to the overpayment deducted from any future benefits payable to the individual or by having the individual pay to the department a sum equal to the overpayment.

If the department determines that an overpayment has been made, the charge for the overpayment against the employer's account shall be removed and the account shall be credited with an amount equal to the overpayment from the unemployment compensation trust fund and this credit shall include both contributory and reimbursable employers, notwithstanding section 96.8, subsection 5.

The administrative law judge concludes that claimant is overpaid unemployment insurance benefits in the amount of \$168.00 pursuant to Iowa Code Section 96.3-7 as the disqualification decision that created the overpayment decision has now been reversed. All of the pay should have been attributed to the first week of unemployment. Claimant worked on an overtime-incentive plan, which gave extra vacation pay for overtime hours worked. Claimant had one week of vacation pay accrued on the incentive program. The vacation pay should not have been split into two weeks.

DECISION:

The decision of the representative dated December 30, 2003, reference 03, is reversed. Claimant is not overpaid unemployment insurance benefits in the amount of \$168.00.
