## STATEMENT OF THE CASE:

The claimant, Desiree Jozefowicz, filed an appeal from the May 23, 2023 (reference 07), unemployment insurance, decision that denied benefits based upon her voluntary quit without good cause attributable to the employer. The parties were properly notified about the hearing. A telephone hearing was held on June 26, 2023 at 1:00 p.m. Claimant, Desiree Jozefowicz, participated and testified. Employer, The Meth-Wick Community Inc, participated and testified through Barb Teply. No exhibits were offered or admitted.

## ISSUE:

Was the separation a layoff, discharge for misconduct or voluntary quit without good cause attributable to the employer?

## FINDINGS OF FACT:

Having reviewed all of the evidence in the record, the administrative law judge finds: Claimant was employed full-time beginning March 29, 2023 as a Certified Nursing Assistant. Claimant's immediate supervisor was Shalonda Young. Claimant last physically worked for the employer on May 1, 2023. On May 4, 2023 the claimant submitted her resignation via telephone. On May 4, 2023, the claimant called the scheduler and stated she needed to resign due to issues in her family life. The claimant had been fighting an eviction since November 2022 due to her dog biting someone working in her home neighborhood. The claimant had initially won the eviction hearing, but in May 2023, the claimant lost the eviction hearing and was forced into an emergency eviction. The claimant had no place to stay locally and moved to Illinois where she had available housing. Continuing work was available had the claimant not resigned.

## **REASONING AND CONCLUSIONS OF LAW:**

For the reasons that follow, the administrative law judge concludes claimant's separation from the employment was without good cause attributable to the employer.

Iowa Code section 96.5(1) provides:

An individual shall be disqualified for benefits:

1. Voluntary quitting. If the individual has left work voluntarily without good cause attributable to the individual's employer, if so found by the department.

Iowa Admin. Code r. 871-24.25 provides:

Voluntary quit without good cause. In general, a voluntary quit means discontinuing the employment because the employee no longer desires to remain in the relationship of an employee with the employer from whom the employee has separated. The employer has the burden of proving that the claimant is disqualified for benefits pursuant to Iowa Code section 96.5. However, the claimant has the initial burden to produce evidence that the claimant is not disqualified for benefits in cases involving Iowa Code section 96.5, subsection (1), paragraphs "a" through "i," and subsection 10. The following reasons for a voluntary quit shall be presumed to be without good cause attributable to the employer:

- The claimant moved to a different locality. (Iowa Admin. Code r. 871-24.25(2)

- Serious family needs (Iowa Admin. Code r. 871-24.25(23))

Claimant has the burden of proving that the voluntary leaving was for good cause attributable to the employer. Iowa Code § 96.6(2). "Good cause" for leaving employment must be that which is reasonable to the average person, not the overly sensitive individual or the claimant in particular. *Uniweld Products v. Indus. Relations Comm'n*, 277 So.2d 827 (Fla. Dist. Ct. App. 1973). A voluntary leaving of employment requires an intention to terminate the employment relationship accompanied by an overt act of carrying out that intention. *Local Lodge #1426 v. Wilson Trailer*, 289 N.W.2d 608, 612 (Iowa 1980).

When the claimant submitted her resignation, she was dealing with a forced eviction from her home. Because she had nowhere she could stay, she moved to Illinois. The claimant's eviction was not related to her employment. The eviction was due to a person issue stemming from a dog bite. While claimant submitting a resignation was understandable under the circumstances, it was not for a good-cause reason attributable to the employer according to Iowa law. Benefits are denied.

## **DECISION:**

The May 23, 2023, (reference 07) unemployment insurance decision is affirmed. The claimant voluntarily left her employment without good cause attributable to the employer. Benefits are withheld until such time as she has worked in and been paid wages for insured work equal to ten times her weekly benefit amount, provided she is otherwise eligible.

AN APPEAL TO THE BOARD SHALL STATE CLEARLY:

1) The name, address, and social security number of the claimant.

2) A reference to the decision from which the appeal is taken.

3) That an appeal from such decision is being made and such appeal is signed.

4) The grounds upon which such appeal is based.

An Employment Appeal Board decision is final agency action. If a party disagrees with the Employment Appeal Board decision, they may then file a petition for judicial review in district court.

2. If no one files an appeal of the judge's decision with the Employment Appeal Board within fifteen (15) days, the decision becomes final agency action, and you have the option to file a petition for judicial review in District Court within thirty (30) days after the decision becomes final.
