Iowa Code § 96.6(2) – Timeliness of Protest

STATEMENT OF THE CASE:

Baggios Italian Restaurant LLC, the employer/appellant, filed an appeal from the Iowa Workforce Development (IWD) July 22, 2022, (reference 03) unemployment insurance (UI) decision that allowed REGUALR (state) UI benefits because the employer's protest was not filed on time. The parties were properly notified of the hearing. A telephone hearing was held on August 22, 2022. The employer participated through Baggio Qerimi, general manager. Mr. Wearmouth did not participate in the hearing. The administrative law judge took official notice of the administrative record, including the fact-finding documents.

ISSUES:

Is the employer's protest filed on time?

FINDINGS OF FACT:

Having reviewed the evidence in the record, the administrative law judge finds: IWD mailed Mr. Wearmouth's notice of claim notice to the employer's accountant on July 7, 2022. The employer's address of record is different than the employer's accountant's address. The notice of claim contains a warning that the employer's protest response is due ten days from the initial notice date. If the date falls on a Saturday, Sunday, or legal holiday, the appeal period is extended to the next working day. July 17, 2022 was a Sunday; therefore, the deadline was extended to Monday, July 18, 2022.

The accounting firm had been sold to another company. The employer received the notice from the employer's accountant. The employer completed the notice and sent it to IWD as soon as the employer receive the notice. The employer sent the notice to IWD on July 20.

REASONING AND CONCLUSIONS OF LAW:

For the reasons that follow, the administrative law judge concludes the employer's protest of the July 7, 2022 notice was filed on time.

lowa Code § 96.6(2) provides, in pertinent part: "[u]nless the claimant or other interested party, after notification or within ten calendar days after notification was mailed to the claimant's last known address, files an appeal from the decision, the decision is final, and benefits shall be paid or denied in accordance with the decision."

Iowa Admin. Code r. 871-24.35(1) provides:

- 1. Except as otherwise provided by statute or by division rule, any payment, appeal, application, request, notice, objection, petition, report or other information or document submitted to the division shall be considered received by and filed with the division:
- (a) If transmitted via the United States Postal Service on the date it is mailed as shown by the postmark, or in the absence of a postmark the postage meter mark of the envelope in which it is received; or if not postmarked or postage meter marked or if the mark is illegible, on the date entered on the document as the date of completion.
- (b) If transmitted via the State Identification Date Exchange System (SIDES), maintained by the United States Department of Labor, on the date it was submitted to SIDES.
- (c) If transmitted by any means other than [United States Postal Service or the State Identification Data Exchange System (SIDES)], on the date it is received by the division.

Iowa Admin. Code r. 871-24.35(2) provides:

2. The submission of any payment, appeal, application, request, notice, objection, petition, report or other information or document not within the specified statutory or regulatory period shall be considered timely if it is established to the satisfaction of the division that the delay in submission was due to division error or misinformation or to delay or other action of the United States postal service.

The lowa Supreme Court has declared that there is a mandatory duty to file appeals from representatives' decisions within the time allotted by statute, and that the administrative law judge has no authority to change the decision of a representative if a timely appeal is not filed. *Franklin v. IDJS*, 277 N.W.2d 877, 881 (Iowa 1979). Compliance with appeal notice provisions is jurisdictional unless the facts of a case show that the notice was invalid. *Beardslee v. IDJS*, 276 N.W.2d 373, 377 (Iowa 1979); see also *In re Appeal of Elliott* 319 N.W.2d 244, 247 (Iowa 1982).

In this case, the employer's protest was filed on July 20, 2022, which was after the July 18, 2022 deadline. However, IWD did not mail the notice to the employer, but instead to the employer's account. The department did not participate in the hearing to provide any additional details about where the notice was sent and why. The notice was not available to the administrative law judge on the department's Alfresco or Client Information Database systems. The employer filed its protest as soon as it received the notice. The employer's protest was filed on time.

DECISION:

The employer's protest of the July 7 2022 notice was filed on time. The July 22, 2022 (reference 03) decision is REVERSED.

REMAND:

The issue of Mr. Wearmouth's separation from employment with this employer is REMANDED (sent back) to the IWD Benefits Bureau for investigation and a decision.

APPEAL RIGHTS. If you disagree with the decision, you or any interested party may:

1. Appeal to the Employment Appeal Board within fifteen (15) days of the date under the judge's signature by submitting a written appeal via mail, fax, or online to:

The appeal period will be extended to the next business day if the last day to appeal falls on a weekend or a legal holiday.

AN APPEAL TO THE BOARD SHALL STATE CLEARLY:

- 1) The name, address, and social security number of the claimant.
- 2) A reference to the decision from which the appeal is taken.
- 3) That an appeal from such decision is being made and such appeal is signed.
- 4) The grounds upon which such appeal is based.

An Employment Appeal Board decision is final agency action. If a party disagrees with the Employment Appeal Board decision, they may then file a petition for judicial review in district court.

2. If no one files an appeal of the judge's decision with the Employment Appeal Board within fifteen (15) days, the decision becomes final agency action, and you have the option to file a petition for judicial review in District Court within thirty (30) days after the decision becomes final. Additional information on how to file a petition can be found at lowa Code §17A.19, which is online at https://www.legis.iowa.gov/docs/code/17A.19.pdf or by contacting the District Court Clerk of Court https://www.iowacourts.gov/iowa-courts/court-directory/.

Note to Parties: YOU MAY REPRESENT yourself in the appeal or obtain a lawyer or other interested party to do so provided there is no expense to Workforce Development. If you wish to be represented by a lawyer, you may obtain the services of either a private attorney or one whose services are paid for with public funds.

Note to Claimant: It is important that you file your weekly claim as directed, while this appeal is pending, to protect your continuing right to benefits.
