Iowa Code § 96.3(7) – Overpayment of Benefits

## STATEMENT OF THE CASE:

The claimant filed an appeal from the May 15, 2023 (reference 07) unemployment insurance decision that found that the claimant was overpaid unemployment insurance benefits of \$539.00 for one week ending March 25, 2023. The parties were properly notified of the hearing. A telephone hearing was scheduled for June 12, 2023. The claimant participated personally. Iowa Workforce Development Integrity Bureau did not participate. The administrative law judge took official notice of the administrative record.

Prior to the hearing, in appeal 23A-UI-04385-AR-T, an administrative law judge reversed the department's decision that caused the overpayment of benefits. As such, no hearing was necessary regarding this appeal because the overpayment stemmed from the effect of 23A-UI-04385-AR-T.

## **ISSUE:**

Was the claimant overpaid benefits for the week ending March 25, 2023?

## FINDINGS OF FACT:

Having reviewed all of the evidence in the record, the administrative law judge finds: Claimant filed for unemployment insurance benefits effective December 18, 2022. For the week ending March 25, 2023, the claimant was paid regular unemployment insurance benefits of \$539.00.

An unemployment insurance decision was issued on April 21, 2023, (reference 05) which found that the claimant was not eligible for regular unemployment insurance benefits for the week ending March 25, 2023, because the claimant did not perform an active work search. That decision was reversed in Appeal No. 23A-UI-04385-AR-T, wherein the administrative law judge held the claimant did make an active search for work for the week ending March 25, 2023, and was therefore able to and available for work. As such, no overpayment of benefits exists.

## **REASONING AND CONCLUSIONS OF LAW:**

For the reasons that follow, the administrative law judge concludes as follows:

Iowa Code section 96.3(7) provides:

- 7. Recovery of overpayment of benefits.
- a. If an individual receives benefits for which the individual is subsequently determined to be ineligible, even though the individual acts in good faith and is not otherwise at fault, the benefits shall be recovered. The department in its discretion may recover the overpayment of benefits either by having a sum equal to the overpayment deducted from any future benefits payable to the individual or by having the individual pay to the department a sum equal to the overpayment.
- b. (1) (a) If the department determines that an overpayment has been made, the charge for the overpayment against the employer's account shall be removed and the account shall be credited with an amount equal to the overpayment from the unemployment compensation trust fund and this credit shall include both contributory and reimbursable employers, notwithstanding section 96.8, subsection 5.

In this case, the April 21, 2023, (reference 05) unemployment insurance decision that found the claimant was not able to and available for work for the week ending March 25, 2023, has been reversed. See Appeal No. 23A-UI-04385-AR-T. Therefore, because the claimant was eligible for benefits for the week ending March 25, 2023, he is not overpaid benefits of \$539.00 for that week.

# **DECISION:**

The May 15, 2023 (reference 07) unemployment insurance decision is reversed. The claimant is not overpaid \$539.00 for the one week ending March 25, 2023, due to not being able to and available for work as that decision was reversed in Appeal No. 23A-UI-04385-AR-T.

- 2) A reference to the decision from which the appeal is taken.
- 3) That an appeal from such decision is being made and such appeal is signed.
- 4) The grounds upon which such appeal is based.

An Employment Appeal Board decision is final agency action. If a party disagrees with the Employment Appeal Board decision, they may then file a petition for judicial review in district court.

2. If no one files an appeal of the judge's decision with the Employment Appeal Board within fifteen (15) days, the decision becomes final agency action, and you have the option to file a petition for judicial review in District Court within thirty (30) days after the decision becomes final. **Note to Parties:** YOU MAY REPRESENT yourself in the appeal or obtain a lawyer or other interested party to do so provided there is no expense to Workforce Development. If you wish to be represented by a lawyer, you may obtain the services of either a private attorney or one whose services are paid for with public funds.

**Note to Claimant:** It is important that you file your weekly claim as directed, while this appeal is pending, to protect your continuing right to benefits.
