871 IAC 26.8(1) – Withdrawal of Appeal

STATEMENT OF THE CASE:

The employer filed a timely appeal from an unemployment insurance decision dated March 1, 2004, reference 07, which allowed benefits to the claimant. At the time of the hearing on April 9, 2004, the employer requested to withdraw the appeal.

FINDINGS OF FACT:

Having examined all matters of record, the administrative law judge finds: The employer, the appellant in this matter, has requested that the appeal be withdrawn.

REASONING AND CONCLUSIONS OF LAW:

A rule found 871 IAC 26.8(1) allows the administrative law judge to grant an appellant's request for the withdrawal of its appeal. A review of all matters of record persuades the administrative law judge that it is appropriate to allow the withdrawal of this appeal.

DECISION:

The unemployment insurance decision dated March 1, 2004, reference 07, remains in effect. The claimant is entitled to receive unemployment insurance benefits, provided she is otherwise eligible.
