Section 96.3-7 - Recovery of Overpayment of Benefits

STATEMENT OF THE CASE:

Jeff D. Simons (claimant) appealed a representative's January 23, 2004 decision (reference 05) that concluded he had been overpaid \$300.00 for the week ending January 10, 2004 because he did not accurately report vacation pay he received during this week. A hearing was held on February 24, 2004. The claimant participated in the hearing. Based on the evidence, the arguments of the claimant, and the law, the administrative law judge enters the following findings of fact, reasoning and conclusions of law, and decision.

ISSUE:

Has the claimant been overpaid \$300.00 in benefits for the week ending January 10, 2004?

FINDINGS OF FACT:

The claimant established a claim for unemployment insurance benefits during the week of December 14, 2003. He filed a claim for the week ending January 10, 2004. The claimant received \$300.00 in benefits for this week.

The claimant appealed a representative's decision that concluded he was not legally entitled to receive benefits for this week. This decision has been reversed. See decision for appeal 04A-UI-01943-DWT.

REASONING AND CONCLUSIONS OF LAW:

If an individual receives benefits he is not legally entitled to receive, the Department shall recover the benefits even if the individual acted in good faith and is not at fault in receiving the overpayment. Iowa Code §96.3-7. Based on the decision for appeal 04A-UI-01943-DWT, the claimant is legally entitled to receive benefits for the week ending January 10, 2004. Therefore, he has not been overpaid any benefits this week.

DECISION:

The representative's January 23, 2004 decision (reference 05) is reversed. The claimant is legally entitled to receive \$300.00 in benefits for the week ending January 10, 2004 and has not been overpaid any benefits this week.
