STATEMENT OF THE CASE:

Claimant filed a timely appeal from the April 18, 2005, reference 01, decision that denied claimant's request to have her claim redetermined due to a business closing. After due notice was issued, a hearing was scheduled to be held on May 12, 2005. Claimant did respond to the hearing notice. Employer did not respond.

FINDINGS OF FACT:

The administrative law judge, having considered the evidence in the record, finds that: A request has been made by the appealing party to withdraw the appeal because the decision appealed has been amended in claimant's favor. The request has been submitted verbally and has been tape-recorded.

REASONING AND CONCLUSIONS OF LAW:

871 IAC 26.8(1) provides:

(1) An appeal may be withdrawn at any time prior to the issuance of a decision upon the request of the appellant and with the approval of the presiding officer to whom the case is assigned. Requests for withdrawal may be made in writing or orally, provided the oral request is tape-recorded by the presiding officer.

The administrative law judge has reviewed the records and files herein and concludes that the request of the appealing party to withdraw the appeal should be approved.

DECISION:

The decision of the representative dated April 18, 2005, reference 01, is affirmed. The request of the appealing party to withdraw the appeal is approved, and the decision of the representative shall stand and remain in full force and effect.
