## STATEMENT OF THE CASE:

Claimant Ahmad J. Omar filed an appeal from the unemployment insurance decision dated September 1, 2022 (reference 09), that he was not eligible for unemployment insurance benefits for the one-week period ending August 6, 2022, because he did not make an active and earnest search for work for that week. Before a hearing was scheduled, lowa Workforce Development issued a favorable decision to the claimant, dated September 15, 2022 (reference 16), stating that he is eligible for unemployment insurance benefits because he did, in fact, make an active work search for the week ending August 6, 2022. This decision made the issue on appeal moot. Therefore, no testimony or additional evidence was necessary. No hearing was scheduled or held.

## ISSUES:

Should the most recent unemployment insurance decision be affirmed? Should the appeal be dismissed as moot?

# **FINDINGS OF FACT:**

These findings of fact are based on the pertinent agency documents relating to this claimant and his appeal. An unemployment insurance decision dated September 1, 2022 (reference 09), determined that the claimant was not eligible for unemployment insurance benefits for the one-week period ending August 6, 2022, because he failed to make an active search for work and meet the reemployment requirements for that week. The claimant appealed this decision. Before a hearing was scheduled, lowa Workforce Development issued a favorable decision to the claimant, dated September 15, 2022 (reference 16), stating that he is eligible for unemployment insurance benefits as long as he meets all the other eligibility requirements. The decision dated September 15, 2022 (reference 16), stated claimant did make an active search for work and meet the reemployment requirements for the week ending August 6, 2022. The

agency representative asked that the appeal be dismissed. This decision resolved the only issue on appeal in the claimant's favor, making the appeal moot.

## **REASONING AND CONCLUSIONS OF LAW:**

Generally, courts and administrative tribunals do not decide issues when the underlying controversy is moot. *Rhiner v. State*, 703 N.W.2d 174, 176 (lowa 2005). "A case is moot if it no longer presents a justiciable controversy because the issues involved are academic or nonexistent." *Iowa Bankers Ass'n v. Iowa Credit Union Dep't*, 335 N.W.2d 439, 442 (lowa 1983)

The decision appealed was amended in favor of the appellant, making this appeal moot. The appeal of the original representative's decision dated September 1, 2022 (reference 09) is dismissed. The most recent decision, dated September 15, 2022 (reference 16), is affirmed.

# **DECISION:**

The request to dismiss the appeal of the unemployment insurance decision dated September 1, 2022 (reference 09) is approved. The decision issued on September 15, 2022 (reference 16) is affirmed. The appeal is dismissed as moot.

**APPEAL RIGHTS.** If you disagree with the decision, you or any interested party may:

1. Appeal to the Employment Appeal Board within fifteen (15) days of the date under the judge's signature by submitting a written appeal via mail, fax, or online to:

The appeal period will be extended to the next business day if the last day to appeal falls on a weekend or a legal holiday. There is no filing fee to file an appeal with the Employment Appeal Board.

## AN APPEAL TO THE BOARD SHALL STATE CLEARLY:

- 1) The name, address, and social security number of the claimant.
- 2) A reference to the decision from which the appeal is taken.
- 3) That an appeal from such decision is being made and such appeal is signed.
- 4) The grounds upon which such appeal is based.

An Employment Appeal Board decision is final agency action. If a party disagrees with the Employment Appeal Board decision, they may file a petition for judicial review in district court.

2. If you do not file an appeal of the judge's decision with the Employment Appeal Board within fifteen (15) days, the decision becomes final agency action, and you have the option to file a petition for judicial review in District Court within thirty (30) days after the decision becomes final. Additional information on how to file a petition can be found at www.iowacourts.gov/efile. There may be a filing fee to file the petition in District Court.

**Note to Parties:** YOU MAY REPRESENT yourself in the appeal or obtain a lawyer or other interested party to do so provided there is no expense to Workforce Development. If you wish to be represented by a lawyer, you may obtain the services of either a private attorney or one whose services are paid for with public funds.

**Note to Claimant:** It is important that you file your weekly claim as directed, while this appeal is pending, to protect your continuing right to benefits.
