871 IAC26.8(1) - Withdrawal of Appeal

STATEMENT OF THE CASE:

Cargill Meat Solutions Corporation (employer) appealed a representative's June 21, 2007 decision (reference 01) that concluded Jessica A. Shields (claimant) was qualified to receive unemployment insurance benefits, and the employer's account was subject to charge because the claimant had been discharged for nondisqualifying reasons. A hearing was scheduled on July 23, 2007. Prior to the hearing, the employer withdrew its appeal in this matter. Based on the employer's withdrawal request, the administrative record, and the law, the administrative law judge enters the following findings of fact, reasoning and conclusions of law, and decision.

FINDINGS OF FACT:

The employer withdrew its appeal from the representative's June 21, 2007 decision. The Appeals Section received the employer's written withdrawal request on July 19, 2007.

REASONING AND CONCLUSIONS OF LAW:

871 IAC 26.8(1) provides:

- (1) An appeal may be withdrawn at any time prior to the issuance of a decision upon the request of the appellant and with the approval of the presiding officer to whom the case is assigned. Requests for withdrawal may be made in writing or orally, provided the oral request is tape-recorded by the presiding officer.

The employer's request to withdraw its appeal is approved.

DECISION:

The representative's June 21, 2007 decision (reference 01) is affirmed. The employer's withdrawal request is approved. The claimant remains qualified to receive unemployment insurance benefits as of June 3, 2007, provided she meets all other eligibility requirements. The employer's account may be charged.
