STATEMENT OF THE CASE:

The claimant filed a timely appeal from the December 23, 2010, reference 01, decision that denied benefits. After due notice was issued, a hearing was held by telephone conference call before Administrative Law Judge Julie Elder on February 10, 2011. The claimant participated in the hearing. The employer notified the Appeals Section it would not be participating in the hearing and was not contesting benefits for the claimant.

ISSUE:

The issue is whether the claimant was laid off.

FINDINGS OF FACT:

Having reviewed all of the evidence in the record, the administrative law judge finds: The claimant is employed as a full-time seasonal groundskeeper for Finkbine Golf Course for The University of Iowa. He began his employment April 1, 1994. He was laid off for the season beginning the week ending November 27, 2010. He will return to his position when weather permits in the spring of 2011. The claimant is not a <u>faculty</u> (emphasis added) member at the University.

REASONING AND CONCLUSIONS OF LAW:

For the reasons that follow, the administrative law judge concludes the claimant was laid off due to a lack of work.

Iowa Code § 96.5-1 provides:

An individual shall be disqualified for benefits:

1. Voluntary quitting. If the individual has left work voluntarily without good cause attributable to the individual's employer, if so found by the department.

The claimant is a full-time seasonal employee of the University's golf course and is laid off each year when weather forces the golf course to close. Therefore, the separation was attributable to a lack of work by the employer. Benefits are allowed effective the week ending November 27, 2010.

DECISION:

The December 23, 2010, reference	01, decision is reversed.	The claimant was laid off	due to a
lack of work. Benefits are allowed,	provided the claimant is o	otherwise eligible.
