STATEMENT OF THE CASE:

On June 16, 2020, the claimant filed an appeal from the June 8, 2020 (reference 01) unemployment insurance decision that denied benefits to the claimant based on a leave of absence. The parties were properly notified about the hearing. A telephone hearing was held on July 22, 2020. Claimant participated personally. The employer, SLB of Iowa LC, participated through witness Karen Beard. Claimant's Exhibits A and B were admitted. The administrative law judge took official notice of the claimant's unemployment insurance benefits records.

ISSUES:

Is the claimant able to and available for work? Is the claimant on an approved leave of absence?

FINDINGS OF FACT:

Having reviewed all of the evidence in the record, the administrative law judge finds: Claimant has worked for the employer since October 22, 2014. She works full-time as a certified trainer. Claimant has medical conditions which place her at a greater risk of complications should she contract the coronavirus. See Exhibit A. Due to the claimant's medical conditions, she was not able to and available for work because of the COVID 19 pandemic and was on a medical leave of absence from April 5, 2020 through July 6, 2020.

REASONING AND CONCLUSIONS OF LAW:

Iowa Code section 96.4(3) provides:

An unemployed individual shall be eligible to receive benefits with respect to any week only if the department finds that:

3. The individual is able to work, is available for work, and is earnestly and actively seeking work. This subsection is waived if the individual is deemed partially unemployed,

while employed at the individual's regular job, as defined in section 96.19, subsection 38, paragraph "b", subparagraph (1), or temporarily unemployed as defined in section 96.19, subsection 38, paragraph "c". The work search requirements of this subsection and the disqualification requirement for failure to apply for, or to accept suitable work of section 96.5, subsection 3 are waived if the individual is not disqualified for benefits under section 96.5, subsection 1, paragraph "h".

Iowa Admin. Code r. 871-24.23(10) provides:

Availability disqualifications. The following are reasons for a claimant being disqualified for being unavailable for work.

(10) The claimant requested and was granted a leave of absence, such period is deemed to be a period of voluntary unemployment and shall be considered ineligible for benefits for such period.

In this case, the claimant's doctor told her she should not work and she was granted a medical leave of absence by the employer. As such, the period of time she is not working is deemed to be a period of voluntary unemployment. Claimant has not established that she was able to and available for work pursuant to Iowa Code § 96.4(3). Therefore, claimant is not eligible for regular, state-funded unemployment insurance benefits while she was not able to and available for work. Regular unemployment insurance benefits funded by the State of Iowa are denied effective April 5, 2020.

DECISION:

The June 8, 2020 (reference 01) unemployment insurance decision is affirmed. The claimant was on a voluntary medical leave of absence and was not able to work and available for work effective April 5, 2020. Unemployment insurance benefits funded by the State of Iowa are denied until such time as the claimant is able to and available for work.

This decision denies benefits. If this decision becomes final or if you are not eligible for PUA, you may have an overpayment of benefits.

- If you have applied and have been approved for PUA benefits, this decision will not negatively affect your entitlement to PUA benefits.
