# STATEMENT OF THE CASE:

Claimant filed a timely appeal from the September 27, 2023 (reference 02) unemployment insurance decision that determined claimant was laid off due to her employer going out of business and her maximum benefit amount was being recalculated on that basis. The parties were properly notified of the hearing. A telephone hearing was held on October 26. Claimant Evelyz Laboy Rivera did not participate. Employer Hy-Vee, Inc. participated through witnesses district manager Joel Jacobson and service manager Megan Farness and hearing representative Kelly Ray. Official notice was taken of the administrative record.

# **ISSUE:**

Whether claimant is eligible to have the monetary determination recalculated due to business closing.

# **FINDINGS OF FACT:**

Having reviewed all of the evidence in the record, the administrative law judge finds: Claimant was employed as a part-time assistant coffee shop manager from September 2, 2020, until September 7, 2023, when she quit.

In May 2023, claimant notified employer she purchased a house in Puerto Rico and would be moving. She was getting work done on the house, so she did not know when her last day would be. In June 2023, employer notified employees it was closing the N. Court Street location where claimant was employed. The location closed on October 15, 2023.

On August 7, 2023, claimant verbally notified employer she was quitting effective September 7, 2023, because she was moving to Puerto Rico. Continuing work was available at the N. Court Street location until October 15, 2023. After that date, employer had work available for claimant at its other Ottumwa location had she remained in Iowa.

## **REASONING AND CONCLUSIONS OF LAW:**

The administrative law judge concludes that the claimant was not laid off as a result of a business closure at the location where she worked and, therefore, is not entitled to a redetermination of wage credits.

Iowa Code section 96.3(5)a provides:

a. Duration of benefits. The maximum total amount of benefits payable to an eligible individual during a benefit year shall not exceed the total of the wage credits accrued to the individual's account during the individual's base period, or sixteen times the individual's weekly benefit amount, whichever is the lesser. The director shall maintain a separate account for each individual who earns wages in insured work. The director shall compute wage credits for each individual by crediting the individual's account with one-third of the wages for insured work paid to the individual during the individual's base period. However, the director shall recompute wage credits for an individual who is laid off due to the individual's employer going out of business at the factory, establishment, or other premises at which the individual was last employed, by crediting the individual's account with one-half, instead of one-third, of the wages for insured work paid to the individual during the individual's base period. Benefits paid to an eligible individual shall be charged against the base period wage credits in the individual's account which have not been previously charged, in the inverse chronological order as the wages on which the wage credits are based were paid. However if the state "off" indicator is in effect and if the individual is laid off due to the individual's employer going out of business at the factory, establishment, or other premises at which the individual was last employed, the maximum benefits payable shall be extended to twenty-six times the individual's weekly benefit amount, but not to exceed the total of the wage credits accrued to the individual's account.

Iowa Admin. Code r. 871-24.29(1) and (2) provide:

Business closing.

(1) Whenever an employer at a factory, establishment, or other premises goes out of business at which the individual was last employed and is laid off, the individual's account is credited with one-half, instead of one-third, of the wages for insured work paid to the individual during the individual's base period, which may increase the maximum benefit amount up to 26 times the weekly benefit amount or one-half of the total base period wages, whichever is less. This rule also applies retroactively for monetary redetermination purposes during the current benefit year of the individual who is temporarily laid off with the expectation of returning to work once the temporary or seasonal factors have been eliminated and is prevented from returning to work because of the going out of business of the employer within the same benefit year of the individual. This rule also applies to an individual who works in temporary employment between the layoff from the business closing employer and the claim for benefits. For the purposes of this rule, temporary employment means employment of a duration not to exceed four weeks.

(2) Going out of business means any factory, establishment, or other premises of an employer which closes its door and ceases to function as a business; however, an employer is not considered to have gone out of business at the factory, establishment, or other premises in any case in which the employer sells or otherwise transfers the business to another employer, and the successor employer continues to operate the business.

Claimant left employment on September 7, 2023. While the location where claimant worked closed on October 15, 2023, it was open and operating at the time claimant left. Employer had continuing work available for claimant, including after the location closed. As claimant was no longer employed at the time the business closed, she is not entitled to a recalculation of benefits.

#### **DECISION:**

The September 27, 2023 (reference 02) unemployment insurance decision is reversed. The claimant was not laid off due to a business closure, but voluntarily quit prior to the business closing. Recalculation of monetary determination is denied.

1. Appeal to the Employment Appeal Board within fifteen (15) days of the date under the judge's signature by submitting a written appeal via mail, fax, or online to:

## AN APPEAL TO THE BOARD SHALL STATE CLEARLY:

- 1) The name, address, and social security number of the claimant.
- 2) A reference to the decision from which the appeal is taken.
- 3) That an appeal from such decision is being made and such appeal is signed.
- 4) The grounds upon which such appeal is based.

An Employment Appeal Board decision is final agency action. If a party disagrees with the Employment Appeal Board decision, they may then file a petition for judicial review in district court.

2. If no one files an appeal of the judge's decision with the Employment Appeal Board within fifteen (15) days, the decision becomes final agency action, and you have the option to file a petition for judicial review in District Court within thirty (30) days after the decision becomes final. **Note to Claimant:** It is important that you file your weekly claim as directed, while this appeal is pending, to protect your continuing right to benefits.
