871 IAC 24.1(113)a – Separations From Employment Section 96.5-1 – Voluntary Leaving - Layoff

STATEMENT OF THE CASE:

Tyson Retail Deli Meats (employer) appealed a representative's January 25, 2005 decision (reference 02) that concluded Brian Welch (claimant) was laid off for lack of work on December 19, 2004. After hearing notices were mailed to the parties' last-known addresses of record, a telephone hearing was held on February 21, 2005. The claimant participated personally. The employer participated by Matt Chase, Employment Manager.

## FINDINGS OF FACT:

The administrative law judge, having heard the testimony and considered all of the evidence in the record, finds that: The claimant was hired on April 5, 2000, as a full-time laborer. The claimant was laid off for lack of work from December 19 through 28, 2004, and January 9 through 17, 2005. The claimant filed for unemployment insurance benefits with an effective date of December 19, 2004.

REASONING AND CONCLUSIONS OF LAW:

For the reasons that follow, the administrative law judge concludes the claimant was laid off due to a lack of work.

Iowa Code Section 96.5-1 provides:

An individual shall be disqualified for benefits:

1. Voluntary quitting. If the individual has left work voluntarily without good cause attributable to the individual's employer, if so found by the department.

871 IAC 24.1(113)a provides:

Separations. All terminations of employment, generally classifiable as layoffs, quits, discharges, or other separations.

a. Layoffs. A layoff is a suspension from pay status initiated by the employer without prejudice to the worker for such reasons as: lack of orders, model changeover, termination of seasonal or temporary employment, inventory-taking, introduction of laborsaving devices, plant breakdown, shortage of materials; including temporarily furloughed employees and employees placed on unpaid vacations.

Therefore, benefits are allowed.

The employer laid the claimant off for lack of work from December 19 through 28, 2004 and January 9 through 17, 2005. When an employer suspends a claimant from work status for a period of time, the separation does not prejudice the claimant. The claimant's separation was attributable to a lack of work by the employer. The claimant is eligible to receive unemployment insurance benefits for that period.

### DECISION:

The representative's January 25, 2005 decision (reference 02) is affirmed. The claimant was laid off due to a lack of work. Benefits are allowed, provided the claimant is otherwise eligible.
