871IAC26.8(1) - Withdrawal of Appeal

STATEMENT OF THE CASE:

Wal-Mart Stores, Inc. (employer) appealed a representative's May 12, 2005 decision (reference 02) that concluded Ryan Sutcliffe (claimant) was qualified to receive unemployment insurance benefits, and the employer's account was subject to charge because the claimant had been discharged for nondisqualifying reasons. A hearing was scheduled for June 10, 2005. Prior to the hearing, the employer made a request to withdraw its appeal. Based on the employer's withdrawal request, the administrative record, and the law, the administrative law judge enters the following findings of fact, reasoning and conclusions of law, and decision.

FINDINGS OF FACT:

The employer's unemployment insurance representative, TALX, faxed a withdrawal request to the Appeals Section on June 8, 2005.

REASONING AND CONCLUSIONS OF LAW:

871 IAC 26.8(1) provides:

(1) An appeal may be withdrawn at any time prior to the issuance of a decision upon the request of the appellant and with the approval of the presiding officer to whom the case is assigned. Requests for withdrawal may be made in writing or orally, provided the oral request is tape-recorded by the presiding officer.

The employer's request to withdraw its appeal is approved.

DECISION:

The representative's May 12, 2005 decision (reference 02) is affirmed. The employer's request to withdraw its appeal is approved. This means as of April 10, 2005, the claimant remains qualified to receive unemployment insurance benefits, provided he meets all other eligibility requirements. The employer's account may be charged for benefits paid to the claimant.
