Iowa Code § 96.3(7) – Recovery of Benefit Overpayment PL116-136. Sec. 2107 –Pandemic Emergency Unemployment Compensation (PEUC)

STATEMENT OF THE CASE:

Arnulfo J Medina, the claimant/appellant, filed an appeal from the August 6, 2021, (reference 08) unemployment insurance decision that concluded he was overpaid Pandemic Emergency Unemployment Compensation (PEUC) benefits in the amount of \$5,319.00. Mr. Medina was properly notified of the hearing. A telephone hearing was held on October 12, 2021. Mr. Medina participated and testified. The administrative law judge took official notice of the administrative record.

ISSUES:

Has Mr. Medina been overpaid PEUC benefits?

FINDINGS OF FACT:

Having reviewed the evidence in the record, the administrative law judge finds: Mr. Medina received PEUC benefits in the amount of \$5,319.00 for 9 weeks between May 31, 2020 and August 1, 2020.

On September 9, 2020, Iowa Workforce Development issued a reference 04 decision finding Mr. Medina was not eligible for REGULAR UI benefits as of May 31, 2020. The administrative law judge's decision in Appeal 21A-UI-18233-DZ-T affirmed the reference 04 decision.

Mr. Medina applied for Pandemic Unemployment Assistance (PUA) benefits on September 21, 2020. The Iowa Workforce Development decision dated November 6, 2020 determined that he was not eligible for Pandemic Unemployment Assistance (PUA) benefits. Mr. Medina appealed. The administrative law judge's decision in Appeal 21R-DUA-01366-DZ-T modified the November 6, 2020 decision in favor of Mr. Medina and found him eligible for PUA benefits as of May 31, 2020. Governor Reynolds ended Iowa's participate in the federal COVID-19 unemployment insurance programs, including the PUA program, as of June 12, 2021. As a result, Mr. Medina's eligibility for PUA benefits ended on June 12, 2021.

REASONING AND CONCLUSIONS OF LAW:

For the reasons that follow, the administrative law judge concludes Mr. Medina has been overpaid PEUC benefits.

Iowa Code §96.3(7) provides, in pertinent part:

- 7. Recovery of overpayment of benefits.
- a. If an individual receives benefits for which the individual is subsequently determined to be ineligible, even though the individual acts in good faith and is not otherwise at fault, the benefits shall be recovered. The department in its discretion may recover the overpayment of benefits either by having a sum equal to the overpayment deducted from any future benefits payable to the individual or by having the individual pay to the department a sum equal to the overpayment.
- b. (1) (a) If the department determines that an overpayment has been made, the charge for the overpayment against the employer's account shall be removed and the account shall be credited with an amount equal to the overpayment from the unemployment compensation trust fund and this credit shall include both contributory and reimbursable employers, notwithstanding section 96.8, subsection 5.

Section 2107 of the CARES Act created a new temporary federal program called Pandemic Emergency Unemployment Compensation (PEUC) that initially provided up to 13 additional weeks of benefits to individuals who have exhausted their regular unemployment compensation entitlement and also provides funding to states to administer the program.

PL 116-136 Sec 2107 provides in pertinent part:

PANDEMIC EMERGENCY UNEMPLOYMENT COMPENSATION.

- (a) FEDERAL-STATE AGREEMENTS. —
- (1) IN GENERAL. Any State which desires to do so may enter into and participate in an agreement under this section with the Secretary of Labor (in this section referred to as the "Secretary"). Any State which is a party to an agreement under this section may, upon providing 30 days' written notice to the Secretary, terminate such agreement.
- (2) PROVISIONS OF AGREEMENT. —

Any agreement under paragraph (1) shall provide that the State agency of the State will make payments of pandemic emergency unemployment compensation to individuals who—

- (A) have exhausted all rights to regular compensation under the State law or under Federal law with respect to a benefit year (excluding any benefit year that ended before July 1, 2019);
- (B) have no rights to regular compensation with respect to a week under such law or any other State unemployment compensation law or to compensation under any other Federal law:

- (C) are not receiving compensation with respect to such week under the unemployment compensation law of Canada; and
- (D) are able to work, available to work, and actively seeking work.

Because Mr. Medina is disqualified from receiving REGULAR UI benefits, he is also disqualified from receiving PEUC benefits. The administrative law judge concludes that Mr. Medina has been overpaid PEUC benefits in the gross amount of \$5,319.00 for 9 weeks between May 31, 2020 and August 1, 2020, which should be repaid.

DECISION:

The August 6, 2021, (reference 08) unemployment insurance decision is affirmed. Mr. Medina has been overpaid PEUC benefits in the amount of \$5,319.00, which must be repaid.

REMAND:

This matter is remanded (sent back) to the Benefits Bureau of Iowa Workforce Development for a review of whether Mr. Medina is eligible for PEUC benefits based on his approval for PUA benefits.
