Section 96.4-3 – Eligibility for Benefits

STATEMENT OF THE CASE:

Renee L. Jensen filed a timely appeal believed to be from an unemployment insurance decision dated December 11, 2003, reference 01, which denied benefits indefinitely as of November 23, 2003 upon a finding that Ms. Jensen was unable to work due to illness. Due notice was issued for a telephone hearing to be held February 19, 2004. At the time of the hearing, Ms. Jensen clarified that her actual intent was to appeal a monetary determination. A subsequent fact-finding decision dated December 18, 2003 had allowed benefits to Ms. Jensen effective December 7, 2003. Under these circumstances, it was unnecessary to take testimony on this issue.

FINDINGS OF FACT:

Having examined all matters of record, the administrative law judge finds: Renee L. Jensen has received unemployment insurance benefits since December 7, 2003.

REASONING AND CONCLUSIONS OF LAW:

The question is whether Ms. Jensen meets the eligibility requirement of being medically able to work. The administrative law judge concludes from Agency decision records and benefit payment records that Ms. Jensen has met the requirement continuously since December 7, 2003.

DECISION:

The unemployment insurance decision dated December 11, 2003, reference 01, is modified. Benefits are withheld from November 23, 2003 through December 6, 2003 because the claimant was medically unable to work. The claimant is entitled to receive unemployment insurance benefits effective December 7, 2003, provided she is otherwise eligible.
