Section 96.3-7 - Recovery of Overpayment of Benefits

## STATEMENT OF THE CASE:

Debrea L. Freisinger (claimant) appealed a representative's December 1, 2005 decision (reference 04) that concluded she had been overpaid unemployment insurance benefits. A hearing notice was mailed to the claimant's last-known address of record for a telephone hearing to be held on December 29, 2005. This appeal was consolidated for hearing with one related appeal, 05A-UI-12380-DT. Prior to the hearing being held, the administrative law judge determined that no hearing was necessary and a decision was made on the record.

## FINDINGS OF FACT:

A representative issued a decision dated November 30, 2005 (reference 03) that concluded the claimant was disqualified from receiving benefits after a separation from employment from

Quebecor World Dubuque, Inc. (employer). The claimant timely appealed that decision and in the concurrently issued decision in appeal 05A-UI-12380-DT, that decision has been modified to remove the disqualification.

The overpayment decision was issued in this case as a result of the November 30, 2005 (reference 03) disqualification decision.

## REASONING AND CONCLUSIONS OF LAW:

The issue in this case is whether the claimant is overpaid benefits of \$404.00 for the three weeks beginning October 23 and ending November 19, 2005.

Iowa Code section 96.3-7 provides:

7. Recovery of overpayment of benefits. If an individual receives benefits for which the individual is subsequently determined to be ineligible, even though the individual acts in good faith and is not otherwise at fault, the benefits shall be recovered. The department in its discretion may recover the overpayment of benefits either by having a sum equal to the overpayment deducted from any future benefits payable to the individual or by having the individual pay to the department a sum equal to the overpayment.

If the department determines that an overpayment has been made, the charge for the overpayment against the employer's account shall be removed and the account shall be credited with an amount equal to the overpayment from the unemployment compensation trust fund and this credit shall include both contributory and reimbursable employers, notwithstanding section 96.8, subsection 5.

The administrative law judge concludes that the claimant is not overpaid benefits due to the disqualification decision issued on November 30, 2005 (reference 03), which has now been modified to remove the disqualification as of at least October 22, 2005.

# **DECISION:**

The representative's December 1, 2005 decision (reference 04) is reversed. The claimant is not overpaid benefits.
