STATEMENT OF THE CASE

The claimant filed an appeal of a representative's decision dated November 19, 2012, reference 03. A Notice of Telephone Hearing was mailed to all parties on December 19, 2012 setting a hearing date of January 22, 2013 at 2:00 PM. The notice contained instructions regarding how to participate in the telephone hearing. Neither the appellant nor any representative from Iowa Workforce Development (the Department) called in to participate in the hearing at the date and time indicated.

The Iowa Administrative Procedure Act provides that if a party fails to appear or participate in a contested case proceeding after proper service of notice, the presiding

officer may enter a default decision. Iowa Workforce Development regulations give the presiding officer discretion regarding whether to proceed with a hearing in the absence of one or more of the parties. In this case, a hearing was not held and a default decision was entered against the appellant.

When neither party appears to present evidence at a contested case hearing, the administrative file is rarely sufficient to support a decision on the merits of the appeal. The task of the administrative law judge is to determine, after careful consideration of the evidence available, whether the Department's decision under appeal was correct. This task is rendered nearly impossible when neither party appears for hearing. Additionally, it is a waste of judicial resources to issue detailed decisions on the merits in cases where neither party has enough investment in the outcome to appear at the contested case hearing and support its position.

DECISION

The appellant's appeal is dismissed. The Department shall take any action necessary to implement this decision.
