871IAC26.8(1) - Withdrawal of Appeal

STATEMENT OF THE CASE:

Teresa Flores Medina (claimant) appealed a representative's July 27, 2005 decision (reference 01) that concluded she was not qualified to receive unemployment insurance benefits, and the account of Temp Associates – Marshalltown (employer) would not be charged, because the claimant voluntarily quit her employment for reasons that do not qualify her to receive benefits. A hearing was scheduled for August 22, 2005. Prior to the hearing, the claimant made a request to withdraw her appeal. Based on the claimant's withdrawal request, the administrative record, and the law, the administrative law judge enters the following findings of fact, reasoning and conclusions of law, and decision.

FINDINGS OF FACT:

The claimant made a written request to withdraw her appeal. The Appeals Section received the claimant's written withdrawal request on August 4, 2005.

REASONING AND CONCLUSIONS OF LAW:

871 IAC 26.8(1) provides:

(1) An appeal may be withdrawn at any time prior to the issuance of a decision upon the request of the appellant and with the approval of the presiding officer to whom the case is assigned. Requests for withdrawal may be made in writing or orally, provided the oral request is tape-recorded by the presiding officer.

The claimant's request to withdraw her appeal is approved.

DECISION:

The representative's July 27, 2005 decision (reference 01) is affirmed. The claimant's request to withdraw her appeal is approved. Therefore, the claimant remains disqualified from receiving unemployment insurance benefits as of June 26, 2005. This disqualification continues until she has been paid ten times her weekly benefit amount for insured work, provided she is otherwise eligible. The employer's account will not be charged.
