Section 96.3-7 – Recovery of Overpayment of Benefits

STATEMENT OF THE CASE:

Lauren N. LeRoy filed a timely appeal from an unemployment insurance decision dated May 17, 2004, reference 03, which ruled that she had been overpaid by \$194.00 for the two weeks ending May 8, 2004. After due notice was issued, a telephone hearing was held June 8, 2004 with Ms. LeRoy participating. This matter is considered on a consolidated record with 04A-UI-05697-AT. The administrative law judge takes official notice of Agency benefit payment records.

Appeal No. 04A-UI-05698-AT

FINDINGS OF FACT:

Having heard the testimony of the witness and having examined all of the evidence in the record, the administrative law judge finds: Lauren N. LeRoy received unemployment insurance benefits in the gross amount of \$194.00 for the two weeks ending May 8, 2004. The fact-finding decision disqualifying her for benefits has been affirmed by the administrative law judge's decision in the companion case.

REASONING AND CONCLUSIONS OF LAW:

The question is whether Ms. LeRoy must repay the benefits in question. She must. Iowa Code Section 96.3-7 requires that unemployment insurance benefits paid in error be repaid to the Agency. The evidence in this record establishes both that Ms. LeRoy received the benefits in question and that the decision disqualifying her for those benefits has been affirmed. Therefore, they must be repaid.

DECISION:

The unemployment insurance decision dated May 17, 2004, reference 03, is affirmed. The claimant has been overpaid in the gross amount of \$194.00 for the two weeks ending May 8, 2004.
