# STATEMENT OF THE CASE:

Claimant filed an appeal from a decision of a representative dated October 10, 2007, reference 01, which held claimant ineligible for unemployment insurance benefits. After due notice, a telephone conference hearing was scheduled for and held on October 29, 2007. Claimant participated. Employer participated by Doug Kenyon, Human Resource Generalist and Kevin Atwood, Department Supervisor.

## **ISSUE:**

The issue in this matter is whether claimant quit for good cause attributable to employer.

### FINDINGS OF FACT:

The administrative law judge, having heard the testimony and considered all of the evidence in the record, finds: Claimant last worked for employer on August 17, 2007. Claimant guit for new and better employment. Claimant had a job offer but it was retracted before claimant was able to start.

### **REASONING AND CONCLUSIONS OF LAW:**

The administrative law judge holds that the evidence has failed to establish that claimant voluntarily quit for good cause attributable to employer when claimant terminated the employment relationship because of new and better employment. This is not good cause attributable to employer for a quit. However quitting for better work does qualify claimant for benefits. Employer's account shall not be charged.

lowa Code section 96.5-1-a provides:

An individual shall be disgualified for benefits:

1. Voluntary quitting. If the individual has left work voluntarily without good cause attributable to the individual's employer, if so found by the department. But the individual shall not be disgualified if the department finds that:

Claimant: Appellant (2)

a. The individual left employment in good faith for the sole purpose of accepting other or better employment, which the individual did accept, and the individual performed services in the new employment. Benefits relating to wage credits earned with the employer that the individual has left shall be charged to the unemployment compensation fund. This paragraph applies to both contributory and reimbursable employers, notwithstanding section 96.8, subsection 5.

871 IAC 24.28(5) provides:

Voluntary quit requalifications and previously adjudicated voluntary quit issues.

(5) The claimant shall be eligible for benefits even though the claimant voluntarily quit if the claimant left for the sole purpose of accepting an offer of other or better employment, which the claimant did accept, and from which the claimant is separated, before or after having started the new employment.

## DECISION:

The decision of the representative dated October 10, 2007, reference 01, is reversed. Unemployment insurance benefits are allowed, provided claimant is otherwise eligible. Employer's account will not be charged by the State of Iowa for benefits paid.
