STATEMENT OF THE CASE

Appellant Charles Gillette appealed two decisions issued by Iowa Workforce Development (the Department) dated January 30, 2013, references 03 and 04. A telephone hearing was scheduled for March 28, 2013 at 1:00 p.m.

At the time set for hearing Appellant appeared and was self-represented. Investigator Karen VonBehren appeared for the Department. Once on the record, Appellant requested that he be allowed to withdraw these appeal.

The Department's regulations permit an appeal to be withdrawn at any time prior to the issuance of a decision upon the request of the Appellant and with the approval of the presiding officer.¹ Therefore Appellant's request should be granted.
