Section 96.5-1 – Voluntary Quit

STATEMENT OF THE CASE:

Employer filed an appeal from a decision of a representative dated December 30, 2003, reference 01, which held claimant eligible for unemployment insurance benefits. After due notice, a telephone conference hearing was scheduled for and held on February 2, 2004. Claimant participated. Employer failed to respond to the hearing notice and did not participate.

FINDINGS OF FACT:

The administrative law judge, having heard the testimony and considered all of the evidence in the record, finds: Claimant last worked for employer on December 2, 2003. Claimant quit

because the employer repeatedly verbally abused him with profanity. On the last incident, claimant was in fear of physical assault. Claimant quit and walked five miles back to town.

#### REASONING AND CONCLUSIONS OF LAW:

The issue in this matter is whether claimant quit for good cause attributable to employer. The administrative law judge holds that the evidence has established that claimant voluntarily quit for good cause attributable to employer because of a detrimental work environment. Verbal abuse and use of profanity perpetrated by the employer are good reasons for a quit attributable to employer. Benefits allowed.

Iowa Code Section 96.5-1 provides:

An individual shall be disqualified for benefits:

1. Voluntary quitting. If the individual has left work voluntarily without good cause attributable to the individual's employer, if so found by the department.

#### DECISION:

The decision of the representative dated December 30, 2003, reference 01, is affirmed. Unemployment insurance benefits are allowed provided claimant is otherwise eligible.
