**STATEMENT OF THE CASE:**

Claimant filed an appeal from the May 16, 2022 (reference 01) unemployment insurance decision that found claimant was overpaid unemployment insurance (UI) benefits in the amount of \$2,240.00 for the eight-week period between March 29, 2020 and May 23, 2020 because she incorrectly reported wages earned from Ballard Golf & Country Club. The parties were properly notified of the hearing. A telephone hearing was held on July 14, 2022. Claimant participated. Employer participated through Greg Ploeger, Treasurer. No exhibits were admitted. Official notice was taken of the administrative record.

**ISSUES:**

Whether claimant is totally, partially or temporarily unemployed.  
Whether claimant correctly reported wages earned.  
Whether claimant is eligible for benefits based on wages earned.  
Whether claimant is overpaid UI benefits.

**FINDINGS OF FACT:**

Having reviewed all of the evidence in the record, the administrative law judge finds:

Claimant filed an initial claim for UI benefits effective March 22, 2020. Claimant's weekly benefit amount was \$472.00. Claimant filed ongoing weekly claims from March 22, 2020 through May 23, 2020. During this time, claimant was employed as a server and bartender. Claimant earned both an hourly wage and tips. Tips are paid out bi-monthly. Neither party provided the amount of tips claimant received during each benefit week. Employer reported that claimant received tips of \$1,424.38 for three pay periods between April 1, 2020 and May 15, 2020. Therefore, claimant's average tips per week were \$222.00 (\$1,424.38 divided by 45 days times 7 days equals \$221.57 per week).

The following chart reflects the weeks that claimant filed ongoing weekly claims, the wages that claimant submitted on her weekly claims, the wages and tips employer reported that claimant earned each week and the amount of UI benefits paid to claimant:

### REASONING AND CONCLUSIONS OF LAW:

For the reasons that follow, the administrative law judge concludes:

Iowa Code section 96.3(7) states:

*7. Recovery of overpayment of benefits.*

a. If an individual receives benefits for which the individual is subsequently determined to be ineligible, even though the individual acts in good faith and is not otherwise at fault, the benefits shall be recovered. The department in its discretion may recover the overpayment of benefits either by having a sum equal to the overpayment deducted from any future benefits payable to the individual or by having the individual pay to the department a sum equal to the overpayment.

Iowa Code section 96.5(5) provides:

An individual shall be disqualified for benefits, regardless of the source of the individual's wage credits:

5. Other compensation.

a. For any week with respect to which the individual is receiving or has received payment in the form of any of the following:

(1) Wages in lieu of notice, separation allowance, severance pay, or dismissal pay.

(2) Compensation for temporary disability under the workers' compensation law of any state or under a similar law of the United States.

(3) A governmental or other pension, retirement or retired pay, annuity, or any other similar periodic payment made under a plan maintained or contributed to by a base period or chargeable employer where, except for benefits under the federal Social Security Act or the federal Railroad Retirement Act of 1974 or the corresponding provisions of prior law, the plan's eligibility requirements or benefit payments are affected by the base period employment or the remuneration for the base period employment. However, this subparagraph shall only be applicable if the base period employer has made one hundred percent of the contribution to the plan.

b. Provided, that if the remuneration is less than the benefits which would otherwise be due under this chapter, the individual is entitled to receive for the week, if otherwise eligible, benefits reduced by the amount of the remuneration. Provided further, if benefits were paid for any week under this chapter for a period when benefits, remuneration or compensation under paragraph "a", subparagraph (1), (2), or (3), were paid on a retroactive basis for the same period, or any part thereof, the department shall recover the excess amount of benefits paid by the department for the period, and no employer's account shall be charged with benefits so paid. However, compensation for service-connected disabilities or compensation for accrued leave based on military service by the beneficiary with the armed forces of the United States, irrespective of the amount of the benefit, does not disqualify any individual otherwise qualified from any of the benefits contemplated herein. A deduction shall not be made from the amount of benefits payable for a week for individuals receiving federal social security pensions to take into account the individuals' contributions to the pension program.

Iowa Admin. Code r. 871-24.18 provides:

Wage-earnings limitation. An individual who is partially unemployed may earn weekly a sum equal to the individual's weekly benefit amount plus \$15 before being disqualified for excessive earnings. If such individual earns less than the individual's weekly benefit amount plus \$15, the formula for wage deduction shall be a sum equal to the individual's weekly benefit amount less that part of wages, payable to the individual with respect to that week and rounded to the lower multiple of one dollar, in excess of one-fourth of the individual's weekly benefit amount.

For the weeks ending April 25, 2020, May 9, 2020 and May 23, 2020, claimant worked and earned more than \$487.00 (her weekly benefit payment of \$472.00 plus \$15.00). Therefore, claimant was not totally or partially unemployed and was not entitled to benefits.

For all other weeks, claimant worked but earned less than \$487.00. Therefore, claimant was partially unemployed and was entitled to partial benefit payments according to the following formula:

$$\begin{aligned} \$ (\text{wages}) - \$ (25\% \text{ of WBA}) &= \$ (\text{wage deduction}) \\ \$ (\text{WBA}) - \$ (\text{wage deduction}) &= \$ (\text{partial weekly benefit amount}) \end{aligned}$$

The following chart reflects the benefits claimant received, the benefits claimant was entitled to and the resulting overpayment:

Claimant was overpaid UI in the amount of \$2,040.00. Claimant is required to repay those benefits.

**DECISION:**

The May 16, 2022 (reference 01) unemployment insurance decision is modified in favor of appellant. Claimant was overpaid UI benefits in the amount \$2,040.00, which must be repaid.

**AN APPEAL TO THE BOARD SHALL STATE CLEARLY:**

- 1) The name, address, and social security number of the claimant.
- 2) A reference to the decision from which the appeal is taken.
- 3) That an appeal from such decision is being made and such appeal is signed.
- 4) The grounds upon which such appeal is based.

An Employment Appeal Board decision is final agency action. If a party disagrees with the Employment Appeal Board decision, they may then file a petition for judicial review in district court.

2. If no one files an appeal of the judge's decision with the Employment Appeal Board within fifteen (15) days, the decision becomes final agency action, and you have the option to file a petition for judicial review in District Court within thirty (30) days after the decision becomes final. **Note to Claimant:** It is important that you file your weekly claim as directed, while this appeal is pending, to protect your continuing right to benefits.
