STATEMENT OF THE CASE:

On May 22, 2024, the employer filed an appeal from the May 9, 2024, (reference 06) statement of charges for the first quarter of 2024. The parties were properly notified about the hearing. A telephone hearing was held on June 11, 2024. Appeal numbers 24A-UI-04985-AR-T and 24A-UI-04986-AR-T were heard together and created one record. Claimant, Travis S. Larson, did not participate. Employer, Crystal Clear Water Co., participated through Owner Ryan Heiken. Department's Exhibit D-1 was admitted. The administrative law judge took official notice of the administrative record.

ISSUES:

Was the employer's protest timely? Was the employer's appeal from the statement of charges timely?

FINDINGS OF FACT:

Having reviewed all of the evidence in the record, the administrative law judge finds: Claimant filed a claim for benefits effective March 19, 2023. The notice of claim was provided to the employer via the online SIDES system on March 24, 2023. The employer completed the protest information and returned the notice of claim via the online SIDES system on March 24, 2023. On April 4, 2023, Iowa Workforce Development (IWD) issued an unemployment insurance decision (reference 01) finding claimant was not eligible for benefits based on the separation from employment. Claimant did not appeal that decision.

On February 6, 2024, IWD issued another decision (reference 05) that determined claimant was able to and available for work. That decision was appealed at the time that the employer appealed the statement of charges. That decision has been reversed. *See* 24A-UI-04985-AR-T.

The claimant's unemployment insurance benefits record reflect that he has earned at least 10 times his weekly benefit amount since the separation from this employer in the first quarter of 2023, but prior to the additional effective date of his claim, which was January 7, 2024.

REASONING AND CONCLUSIONS OF LAW:

For the reasons that follow, the administrative law judge concludes the employer did file a timely appeal to the statement of charges.

Iowa Code section 96.6(2) provides, in pertinent part:

Filing – determination – appeal.

2. Initial determination. A representative designated by the director shall promptly notify all interested parties to the claim of its filing, and the parties have ten days from the date of mailing the notice of the filing of the claim by ordinary mail to the last known address to protest payment of benefits to the claimant.

Iowa Code section 96.7(2)a(6) provides:

Employer contribution and reimbursements.

2. Contribution rates based on benefit experience.

a. (6) Within forty days after the close of each calendar quarter, the department shall notify each employer of the amount of benefits charged to the employer's account during that quarter. The notification shall show the name of each individual to whom benefits were paid, the individual's social security number, and the amount of benefits paid to the individual. An employer which has not been notified as provided in section 96.6, subsection 2, of the allowance of benefits to an individual, may within thirty days after the date of mailing of the notification appeal to the department for a hearing to determine the eligibility of the individual to receive benefits. The appeal shall be referred to an administrative law judge for hearing and the employer and the individual shall receive notice of the time and place of the hearing.

Iowa Admin. Code r. 871—26.4 provides, in relevant part:

2. An appeal from an initial decision concerning the allowance or denial of benefits shall be filed, by mail, facsimile, or e-mail, online, or in person, not later than ten calendar days, as determined by the postmark or the date stamp after the decision was mailed to the party at its last-known address and shall state the following:

- a. The name, address and social security number of the claimant;
- b. A reference to the decision from which appeal is taken; and,
- c. The grounds upon which the appeal is based.

3. Notwithstanding the provisions of subrule 26.4(2), a contributory employer, which has not previously received a notice of the filing of a valid claim for

benefits, may appeal an individual's eligibility to receive benefits within 30 days from the mailing date of the quarterly statement of benefit charges.

4. Also notwithstanding the provisions of subrule 26.4(2), a reimbursable employer, which has not previously received a notice of the filing of a valid claim for benefits, may appeal an individual's eligibility to receive benefits within 15 days of the mailing date of the quarterly billing of benefit charges.

The employer has filed a timely appeal of the statement of charges after timely participating in the agency's determination regarding claimant's eligibility for unemployment insurance benefits. The claimant has requalified for benefits since the separation from this employer and prior to the additional effective date of his claim, which was January 7, 2024. Accordingly, benefits are allowed and the account of the employer shall not be charged.

DECISION:

The May 9, 2024, (reference 06) statement of charges for the first quarter of 2024 is MODIFIED IN FAVOR OF THE APPELLANT, which will appear as a credit to the employer's account on a future statement of charges. The employer has filed a timely appeal of the statement of charges. Claimant has requalified for benefits since the separation. Benefits are allowed, provided the claimant is otherwise eligible. The account of the employer shall not be charged.

AN APPEAL TO THE BOARD SHALL STATE CLEARLY:

1) The name, address, and social security number of the claimant.

2) A reference to the decision from which the appeal is taken.

3) That an appeal from such decision is being made and such appeal is signed.

4) The grounds upon which such appeal is based.

An Employment Appeal Board decision is final agency action. If a party disagrees with the Employment Appeal Board decision, they may then file a petition for judicial review in district court.

2. If no one files an appeal of the judge's decision with the Employment Appeal Board within fifteen (15) days, the decision becomes final agency action, and you have the option to file a petition for judicial review in District Court within thirty (30) days after the decision becomes final. Additional information on how to file a petition can be found at lowa Code §17A.19, which is online at https://www.legis.iowa.gov/docs/code/17A.19.pdf or by contacting the District Court Clerk of Court_https://www.iowacourts.gov/iowa-courts/court-directory/.

Note to Parties: YOU MAY REPRESENT yourself in the appeal or obtain a lawyer or other interested party to do so provided there is no expense to Workforce Development. If you wish to be represented by a lawyer, you may obtain the services of either a private attorney or one whose services are paid for with public funds.

Note to Claimant: It is important that you file your weekly claim as directed, while this appeal is pending, to protect your continuing right to benefits.
