#### STATEMENT OF THE CASE:

On February 15, 2023, Sedona Staffing Inc. (employer) filed an appeal from the statement of charges dated February 9, 2023, reference 06, for the fourth quarter of 2023. A hearing was held on March 6, 2023, pursuant to due notice. Roberto F. Johnson Sr. (claimant) did participate. The employer did participate through Unemployment Benefits Administrator, Colleen McGuinty. The department's Exhibits D1 through D4 were admitted into the record.

# **ISSUES:**

- I. Was the employer's protest timely?
- II. Was the employer's appeal from the statement of charges timely?

# FINDINGS OF FACT:

Having reviewed all of the evidence in the record, the administrative law judge finds: The claimant separated from employment on December 2, 2022 and filed a claim for benefits effective December 4, 2022. The notice of claim was mailed to the employer's address of record on December 12, 2022. The employer received the notice and filed a protest on December 20, 2022. A decision was issued on January 13, 2023 (reference 05) that determined claimant was not eligible to receive unemployment insurance benefits. (Exhibit D2) The first notice the employer received they were being charged for claimant's benefits was the receipt of the statement of charges mailed February 9, 2023 for the fourth quarter of 2022. (Exhibit D3). The employer filed its appeal of that statement of charges on February 15, 2023. (Exhibit D4).

# **REASONING AND CONCLUSIONS OF LAW:**

The administrative law judge concludes that the employer has filed a timely appeal from the fourth quarter of 2022 Statement of Charges.

Iowa Code section 96.6(2) provides, in pertinent part:

2. Initial determination. A representative designated by the director shall promptly notify all interested parties to the claim of its filing, and the parties have ten days from the date of mailing the notice of the filing of the claim by ordinary mail to the last known address to protest payment of benefits to the claimant.

Iowa Admin. Code r. 871-24.35(2) provides:

2. The submission of any payment, appeal, application, request, notice, objection, petition, report or other information or document not within the specified statutory or regulatory period shall be considered timely if it is established to the satisfaction of the division that the delay in submission was due to division error or misinformation or to delay or other action of the United States postal service.

Iowa Code section 96.7(2)a(6) provides:

- 2. Contribution rates based on benefit experience.
- a. (6) Within forty days after the close of each calendar quarter, the department shall notify each employer of the amount of benefits charged to the employer's account during that quarter. The notification shall show the name of each individual to whom benefits were paid, the individual's social security number, and the amount of benefits paid to the individual. An employer which has not been notified as provided in section 96.6, subsection 2, of the allowance of benefits to an individual, may within thirty days after the date of mailing of the notification appeal to the department for a hearing to determine the eligibility of the individual to receive benefits. The appeal shall be referred to an administrative law judge for hearing and the employer and the individual shall receive notice of the time and place of the hearing.

Iowa Admin. Code r. 871-26.4 provides, in relevant part:

- 2. An appeal from an initial decision concerning the allowance or denial of benefits shall be filed, by mail, facsimile, or e-mail, online, or in person, not later than ten calendar days, as determined by the postmark or the date stamp after the decision was mailed to the party at its last-known address and shall state the following:
- a. The name, address and social security number of the claimant;
- b. A reference to the decision from which appeal is taken; and,
- c. The grounds upon which the appeal is based.

- 3. Notwithstanding the provisions of subrule 26.4(2), a contributory employer, which has not previously received a notice of the filing of a valid claim for benefits, may appeal an individual's eligibility to receive benefits within 30 days from the mailing date of the quarterly statement of benefit charges.
- 4. Also notwithstanding the provisions of subrule 26.4(2), a reimbursable employer, which has not previously received a notice of the filing of a valid claim for benefits, may appeal an individual's eligibility to receive benefits within 15 days of the mailing date of the quarterly billing of benefit charges.

The administrative law judge concludes that the Statement of Charges was the first time that the employer was notified that it would be charged for benefits paid to claimant. The agency's previous decision dated January 13, 2023 (reference 05) found that the employer would not be charged for benefits. The employer's appeal of the fourth quarter of 2022 Statement of Charges within thirty days is timely. The Statement of Charges is inconsistent with the agency's previous decision. The account of the employer shall not be charged.

### **DECISION:**

The Statement of Charges dated February 9, 2023 for the fourth quarter of 2022 is modified in favor of the appellant/employer. The employer has filed a timely appeal from that Statement of Charges. The account of the employer shall not be charged. The employer's account shall be credited \$254.00.

APPEAL RIGHTS. If you disagree with the decision, you or any interested party may:

1. Appeal to the Employment Appeal Board within fifteen (15) days of the date under the judge's signature by submitting a written appeal via mail, fax, or online to:

- 2) A reference to the decision from which the appeal is taken.
- 3) That an appeal from such decision is being made and such appeal is signed.
- 4) The grounds upon which such appeal is based.

An Employment Appeal Board decision is final agency action. If a party disagrees with the Employment Appeal Board decision, they may then file a petition for judicial review in district court.

2. If no one files an appeal of the judge's decision with the Employment Appeal Board within fifteen (15) days, the decision becomes final agency action, and you have the option to file a petition for judicial review in District Court within thirty (30) days after the decision becomes final. **Note to Claimant:** It is important that you file your weekly claim as directed, while this appeal is pending, to protect your continuing right to benefits.
