## STATEMENT OF THE CASE:

Lisa A. Fagerlind, the claimant/appellant, filed an appeal from the Iowa Workforce Development (IWD) July 7, 2022 (reference 01) unemployment insurance (UI) decision that denied extended benefits based on a layoff due to business closure. The parties were properly notified about the hearing. A telephone hearing was held on August 19, 2022. Ms. Fagerlind participated personally. The employer participated through Alison Henkle, human resources director. The administrative law judge took official notice of the administrative record.

# **ISSUE:**

Is Ms. Fagerlind eligible for extended UI benefits due to a business closure?

## FINDINGS OF FACT:

Having reviewed the evidence in the record, the administrative law judge finds: Ms. Fagerlind began working for the employer in 2016. She worked as a full-time cook at the employer's Waterloo, lowa location.

On May 15, 2022, the employer told employees that the employer would be closing the Waterloo location in July 2022. The employer told employees that the employer would find positions for each employee who wanted to continue to work for the employer. Before the employer's May 15 announcement, Ms. Fagerlind asked her manager to reduce her hours to part-time hours because of her health issues and because Ms. Fagerlind wanted to begin receiving disability benefits. The employer had reduced Ms. Fagerlind's hours to part-time hours.

The employer offered Ms. Fagerlind a cold chef job and a job delivering food in the employer's facility. Ms. Fagerlind turned down both jobs because of her health issues. Ms. Fagerlind testified that she turned down the chef job because it required her to lift fifty or more pounds, which she is not able to do. The employer closed its Waterloo location on June 25. No other business operates at location at which Ms. Fagerlind used to work

# **REASONING AND CONCLUSIONS OF LAW:**

For the reasons that follow, the administrative law judge concludes as follows:

Iowa Code § 96.3(5)a provides:

5. a. Duration of benefits. The maximum total amount of benefits payable to an eligible individual during a benefit year shall not exceed the total of the wage credits accrued to the individual's account during the individual's base period, or twenty-six times the individual's weekly benefit amount, whichever is the lesser. The director shall maintain a separate account for each individual who earns wages in insured work. The director shall compute wage credits for each individual by crediting the individual's account with one-third of the wages for insured work paid to the individual during the individual's base period. However, the director shall recompute wage credits for an individual who is laid off due to the individual's employer going out of business at the factory, establishment, or other premises at which the individual was last employed, by crediting the individual's account with one-half, instead of one-third, of the wages for insured work paid to the individual during the individual's base period. Benefits paid to an eligible individual shall be charged against the base period wage credits in the individual's account which have not been previously charged, in the inverse chronological order as the wages on which the wage credits are based were paid. However if the state "off" indicator is in effect and if the individual is laid off due to the individual's employer going out of business at the factory, establishment, or other premises at which the individual was last employed, the maximum benefits payable shall be extended to thirty-nine times the individual's weekly benefit amount, but not to exceed the total of the wage credits accrued to the individual's account.

Iowa Admin. Code r. 871-24.29(1) and (2) provide:

- (1) Whenever an employer at a factory, establishment, or other premises goes out of business at which the individual was last employed and is laid off, the individual's account is credited with one-half, instead of one-third, of the wages for insured work paid to the individual during the individual's base period, which may increase the maximum benefit amount up to 39 times the weekly benefit amount or one-half of the total base period wages, whichever is less. This rule also applies retroactively for monetary redetermination purposes during the current benefit year of the individual who is temporarily laid off with the expectation of returning to work once the temporary or seasonal factors have been eliminated and is prevented from returning to work because of the going out of business of the employer within the same benefit year of the individual. This rule also applies to an individual who works in temporary employment between the layoff from the business closing employer and the Claim for Benefits. For the purposes of this rule, temporary employment means employment of a duration not to exceed four weeks.
- (2) Going out of business means any factory, establishment, or other premises of an employer which closes its door and ceases to function as a business; however, an employer is not considered to have gone out of business at the factory, establishment, or other premises in any case in which the employer sells or otherwise transfers the business to another employer, and the successor employer continues to operate the business.

In this case, the employer closed the location at which Ms. Fagerlind worked and no new business operates at that location. Under lowa law, the premises at which Ms. Fagerlind last worked has closed. Therefore, Ms. Fagerlind is entitled to extended benefits based on a business closure.

# **DECISION:**

The July 7, 2022 (reference 01) decision is REVERSED. Ms. Fagerlind was separated from employment due to a business closure. Extended benefits are allowed.

**APPEAL RIGHTS.** If you disagree with the decision, you or any interested party may:

1. Appeal to the Employment Appeal Board within fifteen (15) days of the date under the judge's signature by submitting a written appeal via mail, fax, or online to:

## AN APPEAL TO THE BOARD SHALL STATE CLEARLY:

- 1) The name, address, and social security number of the claimant.
- 2) A reference to the decision from which the appeal is taken.
- 3) That an appeal from such decision is being made and such appeal is signed.
- 4) The grounds upon which such appeal is based.

An Employment Appeal Board decision is final agency action. If a party disagrees with the Employment Appeal Board decision, they may then file a petition for judicial review in district court.

2. If no one files an appeal of the judge's decision with the Employment Appeal Board within fifteen (15) days, the decision becomes final agency action, and you have the option to file a petition for judicial review in District Court within thirty (30) days after the decision becomes final. **Note to Parties:** YOU MAY REPRESENT yourself in the appeal or obtain a lawyer or other interested party to do so provided there is no expense to Workforce Development. If you wish to be represented by a lawyer, you may obtain the services of either a private attorney or one whose services are paid for with public funds.

**Note to Claimant:** It is important that you file your weekly claim as directed, while this appeal is pending, to protect your continuing right to benefits.
