Section 96.5(2)a – Discharge Section 96.3(7) – Overpayment

STATEMENT OF THE CASE:

The employer, Pizza Hut, filed an appeal from a decision dated March 16, 2006, reference 01. The decision allowed benefits to the claimant, David Corbett. After due notice was issued, a hearing was held by telephone conference call on April 13, 2006. The claimant participated on his own behalf. The employer participated by General Manager Jacqueline Orman.

FINDINGS OF FACT:

Having heard the testimony of the witnesses and having examined all of the evidence in the record, the administrative law judge finds: David Corbett was employed by Pizza Hut from August 24, 2004 until February 4, 2006. He was a full-time delivery driver.

General Manager Jacqueline Orman posted signs near the work schedule to notify everyone that Super Bowl Sunday was the store's biggest delivery day of the year. As a consequence, no one would be given the day off and no one was to call in absent without substantial reason.

Mr. Corbett had requested the day off but was denied for the reasons stated above. However, he was no-call/no-show to work that day because he wanted to watch the Super Bowl. He called and talked to Ms. Orman on February 6, 2006, and asked if he still had a job and she told him he did not.

David Corbett has received unemployment benefits since filing a claim with an effective date of February 26, 2006.

REASONING AND CONCLUSIONS OF LAW:

The issue is whether the claimant is disqualified. The judge concludes he is.

Iowa Code section 96.5-2-a provides:

An individual shall be disqualified for benefits:

- 2. Discharge for misconduct. If the department finds that the individual has been discharged for misconduct in connection with the individual's employment:
- a. The individual shall be disqualified for benefits until the individual has worked in and has been paid wages for insured work equal to ten times the individual's weekly benefit amount, provided the individual is otherwise eligible.

871 IAC 24.32(1)a provides:

Discharge for misconduct.

- (1) Definition.
- a. "Misconduct" is defined as a deliberate act or omission by a worker which constitutes a material breach of the duties and obligations arising out of such worker's contract of employment. Misconduct as the term is used in the disqualification provision as being limited to conduct evincing such willful or wanton disregard of an employer's interest as is found in deliberate violation or disregard of standards of behavior which the employer has the right to expect of employees, or in carelessness or negligence of such degree of recurrence as to manifest equal culpability, wrongful intent or evil design, or to show an intentional and substantial disregard of the employer's interests or of the employee's duties and obligations to the employer. On the other hand mere inefficiency, unsatisfactory conduct, failure in good performance as the result of inability or incapacity, inadvertencies or ordinary negligence in isolated instances, or good faith errors in judgment or discretion are not to be deemed misconduct within the meaning of the statute.

This definition has been accepted by the Iowa Supreme Court as accurately reflecting the intent of the legislature. <u>Huntoon v. Iowa Department of Job Service</u>, 275 N.W.2d 445, 448 (Iowa 1979).

The claimant was not discharged for absenteeism but for insubordination. The general manager had made clear to everyone that Super Bowl Sunday was the busiest day of the year and everyone was needed to work. The claimant declined to accept the reasonable orders of the supervisor and refused to come in or to notify anyone he would be absent. This is a violation of the duties and responsibilities an employer has the right to expect of an employee and is conduct not in the best interests of the employer. The claimant is disqualified.

Iowa Code section 96.3-7 provides:

7. Recovery of overpayment of benefits. If an individual receives benefits for which the individual is subsequently determined to be ineligible, even though the individual acts in good faith and is not otherwise at fault, the benefits shall be recovered. The department in its discretion may recover the overpayment of benefits either by having a sum equal to the overpayment deducted from any future benefits payable to the individual or by having the individual pay to the department a sum equal to the overpayment.

If the department determines that an overpayment has been made, the charge for the overpayment against the employer's account shall be removed and the account shall be credited with an amount equal to the overpayment from the unemployment compensation trust fund and this credit shall include both contributory and reimbursable employers, notwithstanding section 96.8, subsection 5.

The claimant has received unemployment benefits to which he is not entitled. These must be recovered in accordance with the provisions of lowa law.

DECISION:

The representative's decision of March 16, 2006, reference 01, is reversed. David Corbett is disqualified and benefits are withheld until he has earned ten times his weekly benefit amount, provided he is otherwise eligible. He is overpaid in the amount of \$684.00.
