STATEMENT OF THE CASE:

Hy-Vee, Inc. (employer) appealed a representative's February 14, 2006 decision (reference 01) that concluded April M. Porter (claimant) was eligible to receive unemployment insurance benefits as of January 8, 2006 because she was on a short-term layoff and was still able to and available for work. A hearing was scheduled on March 14, 2006. Prior the hearing, the employer made a request to withdraw its appeal. Based on the employer's withdrawal request, the administrative record, and the law, the administrative law judge enters the following findings of fact, reasoning and conclusions of law, and decision.

FINDINGS OF FACT:

The employer faxed a withdrawal request from a February 14, 2006 decision on March 7, 2006. The Appeals Section received the employer's written withdrawal request.

REASONING AND CONCLUSIONS OF LAW:

871 IAC 26.8(1) provides:

(1) An appeal may be withdrawn at any time prior to the issuance of a decision upon the request of the appellant and with the approval of the presiding officer to whom the case is assigned. Requests for withdrawal may be made in writing or orally, provided the oral request is tape-recorded by the presiding officer.

The employer's request to withdraw its appeal is approved.

DECISION:

The representative's February 14, 2006, 2005 decision (reference 01) is affirmed. The employer's withdrawal request is approved. The claimant remains eligible to receive unemployment insurance benefits as of January 8, 2006, provided she meets all other eligibility requirements.
