STATEMENT OF THE CASE:

On August 24, 2022, Advance Services, Inc. (employer) filed an appeal from the statement of charges dated August 9, 2022, reference 01, for the second quarter of 2022. A hearing was scheduled for 11:00 a.m. on Thursday, October 20, 2022, pursuant to due notice. However, the administrative record contained sufficient information that the administrative law judge was able to issue a decision without the need for a hearing.

ISSUES:

Was the employer's protest timely? Was the employer's appeal from the statement of charges timely?

FINDINGS OF FACT:

Having reviewed all of the evidence in the record, the administrative law judge finds: The claimant filed a claim for benefits effective March 6, 2022. The notice of claim was made available to the employer through the online SIDES system on March 11, 2022. The administrative record shows that the employer responded to this notice of claim with protest information on March 14, 2022. lowa Workforce Development ("IWD") never scheduled a fact-finding interview or issued an unemployment insurance decision determining eligibility for benefits based on the claimant's separation from the employer.

On August 9, 2022, IWD mailed the employer a statement of charges reflecting charges for benefits for the second quarter of 2022. The employer appealed this statement of charges on August 24. 2022.

REASONING AND CONCLUSIONS OF LAW:

For the reasons that follow, the administrative law judge concludes the timely responded to the notice of claim; further it timely appealed the statement of charges.

lowa Code section 96.6(2) provides, in pertinent part:

Filing – determination – appeal.

2. Initial determination. A representative designated by the director shall promptly notify all interested parties to the claim of its filing, and the parties have ten days from the date of mailing the notice of the filing of the claim by ordinary mail to the last known address to protest payment of benefits to the claimant.

lowa Code section 96.7(2)a(6) provides:

Employer contribution and reimbursements.

- 2. Contribution rates based on benefit experience.
- a. (6) Within forty days after the close of each calendar quarter, the department shall notify each employer of the amount of benefits charged to the employer's account during that quarter. The notification shall show the name of each individual to whom benefits were paid, the individual's social security number, and the amount of benefits paid to the individual. An employer which has not been notified as provided in section 96.6, subsection 2, of the allowance of benefits to an individual, may within thirty days after the date of mailing of the notification appeal to the department for a hearing to determine the eligibility of the individual to receive benefits. The appeal shall be referred to an administrative law judge for hearing and the employer and the individual shall receive notice of the time and place of the hearing.

lowa Admin. Code r. 871-26.4 provides, in relevant part:

- 2. An appeal from an initial decision concerning the allowance or denial of benefits shall be filed, by mail, facsimile, or e-mail, online, or in person, not later than ten calendar days, as determined by the postmark or the date stamp after the decision was mailed to the party at its last-known address and shall state the following:
- a. The name, address and social security number of the claimant;
- b. A reference to the decision from which appeal is taken; and,
- c. The grounds upon which the appeal is based.
- 3. Notwithstanding the provisions of subrule 26.4(2), a contributory employer, which has not previously received a notice of the filing of a valid claim for benefits, may appeal an individual's eligibility to receive benefits within 30 days from the mailing date of the quarterly statement of benefit charges.
- 4. Also notwithstanding the provisions of subrule 26.4(2), a reimbursable employer, which has not previously received a notice of the filing of a valid claim

for benefits, may appeal an individual's eligibility to receive benefits within 15 days of the mailing date of the quarterly billing of benefit charges.

The information included in the administrative record demonstrates that the employer promptly responded to the notice of claim with protest information regarding claimant's separation from employment. Additionally, after receiving notice that it was being charged for benefits paid to the claimant, the employer filed its appeal of the statement of charges within the time period prescribed by the lowa Employment Security. The employer's appeal of that statement within thirty days is timely.

The issue of whether the claimant's separation qualifies him for benefits is remanded to the Benefits Bureau for a fact-finding interview and unemployment insurance decision.

DECISION:

The August 9, 2022, reference 01, statement of charges for the second quarter of 2022 is affirmed, pending the outcome of the remanded issue. The employer has filed a timely appeal from that statement of charges.

REMAND:

The issue of whether the claimant's separation qualifies him for benefits is remanded to the Benefits Bureau for a fact-finding interview and unemployment insurance decision.

- 3) That an appeal from such decision is being made and such appeal is signed.
- 4) The grounds upon which such appeal is based.

An Employment Appeal Board decision is final agency action. If a party disagrees with the Employment Appeal Board decision, they may then file a petition for judicial review in district court.

2. If no one files an appeal of the judge's decision with the Employment Appeal Board within fifteen (15) days, the decision becomes final agency action, and you have the option to file a petition for judicial review in District Court within thirty (30) days after the decision becomes final. Note to Parties: YOU MAY REPRESENT yourself in the appeal or obtain a lawyer or other interested party to do so provided there is no expense to Workforce Development. If you wish to be represented by a lawyer, you may obtain the services of either a private attorney or one whose services are paid for with public funds.

Note to Claimant: It is important that you file your weekly claim as directed, while this appeal is pending, to protect your continuing right to benefits.
