## STATEMENT OF THE CASE:

On December 8, 2022, Casey's Marketing Company (employer) filed an appeal from the statement of charges dated November 9, 2022, reference 11, for the third quarter of 2022. A hearing was held on January 10, 2023, pursuant to due notice. Peter L. Austin (claimant) did not participate. Employer participated through third-party hearing representative Marideliz Ortiz. The administrative law judge took official notice of the administrative record, including the SIDES system notice of claim and employer response, the unemployment insurance decision issued April 20, 2022 (reference 01), appeal decisions 22A-UI-10768-DH-T and 22A-UI-17979-LJ-T, the August 9, 2022, and November 9, 2022, statement of charges, and the December 8, 2022, appeal.

# **ISSUES:**

Was the employer's protest timely? Was the employer's appeal from the statement of charges timely?

## FINDINGS OF FACT:

Having reviewed all of the evidence in the record, the administrative law judge finds: The notice of claim was sent to employer's address of record on April 5, 2022. Employer received the notice of claim and filed a statement of protest on April 14, 2022. An April 20, 2022, (reference 01) decision allowed benefits. Employer received and appealed the decision but did not appear for the hearing. A decision was issued on August 12, 2022, dismissing the appeal. (See 22A-UI-10768-DH-T). Employer received the administrative law judge's decision in the mail. On August 9, 2022, a statement of charges was mailed to the employer for the second quarter of 2022. The employer filed its appeal of that statement of charges on August 31, 2022. Employer appealed the did not appear for the hearing. A decision was issued on November 15, 2022, dismissing the appeal. (See 22A-UI-17979-LJ-T). On November 9, 2022, a statement of charges was mailed to the employer for the third quarter of 2022. The employer filed its appeal of that statement of charges on December 8, 2022.

## **REASONING AND CONCLUSIONS OF LAW:**

For the reasons that follow, the administrative law judge concludes employer has not appropriately filed an appeal of the statement of charges.

Iowa Code section 96.6(2) provides, in pertinent part:

2. Initial determination. A representative designated by the director shall promptly notify all interested parties to the claim of its filing, and the parties have ten days from the date of mailing the notice of the filing of the claim by ordinary mail to the last known address to protest payment of benefits to the claimant.

Iowa Code section 96.7(2)a(6) provides:

- 2. Contribution rates based on benefit experience.
- a. (6) Within forty days after the close of each calendar quarter, the department shall notify each employer of the amount of benefits charged to the employer's account during that quarter. The notification shall show the name of each individual to whom benefits were paid, the individual's social security number, and the amount of benefits paid to the individual. An employer which has not been notified as provided in section 96.6, subsection 2, of the allowance of benefits to an individual, may within thirty days after the date of mailing of the notification appeal to the department for a hearing to determine the eligibility of the individual to receive benefits. The appeal shall be referred to an administrative law judge for hearing and the employer and the individual shall receive notice of the time and place of the hearing. [Emphasis added.]

Iowa Admin. Code r. 871-26.4 provides, in relevant part:

- 2. An appeal from an initial decision concerning the allowance or denial of benefits shall be filed, by mail, facsimile, or e-mail, online, or in person, not later than ten calendar days, as determined by the postmark or the date stamp after the decision was mailed to the party at its last-known address and shall state the following:
- a. The name, address and social security number of the claimant;
- b. A reference to the decision from which appeal is taken; and,
- c. The grounds upon which the appeal is based.
- 3. Notwithstanding the provisions of subrule 26.4(2), a contributory employer, which has not previously received a notice of the filing of a valid claim for benefits, may appeal an individual's eligibility to receive benefits within 30 days from the mailing date of the quarterly statement of benefit charges.
- 4. Also notwithstanding the provisions of subrule 26.4(2), a reimbursable employer, which has not previously received a notice of the filing of a valid claim for benefits, may appeal an individual's eligibility to receive benefits within 15 days of the mailing date of the quarterly billing of benefit charges.

An employer may appeal a statement of charges when it has not received prior notice of a valid claim for benefits. Here, employer received notice of claimant's filing for unemployment

insurance benefits through the initial notice of claim, the April 20, 2022, (reference 01) unemployment insurance decision, and the November 9, 2022, statement of charges for the second quarter of 2022. Even if employer did not receive the administrative law judge's decisions following the appeal hearing, the appropriate remedy is not an appeal of the statement of charges. The record developed in this hearing illustrates that the employer has received notice of the claimant's filing of a valid claim for benefits, and it may not appeal the quarterly statement of charges.

# **DECISION:**

The November 9, 2022, reference 11, statement of charges for the third quarter of 2022 is affirmed.

**APPEAL RIGHTS.** If you disagree with the decision, you or any interested party may:

1. Appeal to the Employment Appeal Board within fifteen (15) days of the date under the judge's signature by submitting a written appeal via mail, fax, or online to:

The appeal period will be extended to the next business day if the last day to appeal falls on a weekend or a legal holiday.

## AN APPEAL TO THE BOARD SHALL STATE CLEARLY:

- 1) The name, address, and social security number of the claimant.
- 2) A reference to the decision from which the appeal is taken.
- 3) That an appeal from such decision is being made and such appeal is signed.
- 4) The grounds upon which such appeal is based.

An Employment Appeal Board decision is final agency action. If a party disagrees with the Employment Appeal Board decision, they may then file a petition for judicial review in district court.

2. If no one files an appeal of the judge's decision with the Employment Appeal Board within fifteen (15) days, the decision becomes final agency action, and you have the option to file a petition for judicial review in District Court within thirty (30) days after the decision becomes final. **Note to Parties:** YOU MAY REPRESENT yourself in the appeal or obtain a lawyer or other interested party to do so provided there is no expense to Workforce Development. If you wish to be represented by a lawyer, you may obtain the services of either a private attorney or one whose services are paid for with public funds.

**Note to Claimant:** It is important that you file your weekly claim as directed, while this appeal is pending, to protect your continuing right to benefits.
